PURPOSE

To approve various routine parking and traffic modifications.

STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES:

- 4. Make streets safer for everyone.
- 5. Deliver reliable and equitable transportation services.
- 6. Eliminate pollution and greenhouse gas emissions by increasing use of transit, walking, and bicycling.

This action supports the following SFMTA Transit First Policy Principles:

- 1. To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.
- 2. Public transit, including taxis and vanpools, is an economically and environmentally sound alternative to transportation by individual automobiles. Within San Francisco, travel by public transit, by bicycle and on foot must be an attractive alternative to travel by private automobile.
- 3. Decisions regarding the use of limited public street and sidewalk space shall encourage the use of public rights of way by pedestrians, bicyclists, and public transit, and shall strive to reduce traffic and improve public health and safety.

ITEMS

The following items were considered at Public Hearing on September 6, 2024

A. ESTABLISH – RESIDENTIAL PERMIT PARKING AREA C (Eligibility only, no signs) – 900 block of Post Street except for addresses already in RPP (Requested by residents).

Modification A would add RPP eligibility to the residents of the 900 block of Post Street between Larkin and Hyde Streets (except addresses already in RPP) so they can purchase parking permits for their vehicle to park within RPP Area C.

B. ESTABLISH – RESIDENTIAL PERMIT PARKING AREA H (Eligibility only, no signs) – 2500 block of Ocean Avenue between Woodacre Drive and Junipero Serra Blvd (Requested by residents).

Modification B would add RPP eligibility to the residents of the 2500 block of Ocean Avenue between Woodacre Drive and Junipero Serra Blvd (Except for addresses already in RPP Area H) so they can purchase parking permits for their vehicle to park within RPP Area H.

ENVIRONMENTAL REVIEW
