# SAN FRANCISCO MUNICIPAL TRANSPORTATION AGENCY

**DIVISION:** Streets

## **BRIEF DESCRIPTION:**

Approving a Roadway Shared Spaces street closure of Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday; and making environmental review findings.

## **SUMMARY:**

- Roadway Shared Spaces closures which significantly interfere with or delay a public transit service, exceed ten consecutive hours per day over four consecutive days per week, or exceed a total period of time more than two years are considered to be a Longer-Term Closure and therefore require approval from this Board.
- The proposed Roadway Shared Spaces closure would close Elm Street between Van Ness Avenue and Polk Street to vehicular traffic part time.
- The proposed Roadway Shared Spaces closure has been presented at an Interdepartmental Staff Committee on Traffic and Transportation public hearing.
- The proposed Roadway Shared Spaces street closure has been reviewed pursuant to the California Environmental Quality Act (CEQA).

# **PURPOSE**

Approving a Roadway Shared Spaces street closure of Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday; and making environmental review findings.

# STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

This item will support the following goals and objectives of the SFMTA Strategic Plan:

Goal 6: Eliminate pollution and greenhouse gas emissions by increasing use of transit, walking and bicycling.

Goal 7: Build stronger relationships with stakeholders.

This item will support the following Transit First Policy Principles:

- 1. To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.
- 3. Decisions regarding the use of limited public street and sidewalk space shall encourage the use of public rights of way by pedestrians, bicyclists, and public transit, and shall strive to reduce traffic and improve public health and safety.

# DISCUSSION

Tenderloin Community School (TCS) is a PreK-5th Grade public elementary school located on Turk Street between Van Ness Avenue and Polk Street. TCS also has an entrance on Elm Street, a one-way westbound alley parallel to Turk Street. United Way Bay Area (applicant), a nonprofit that operates poverty-fighting programs, has applied for a Roadway Shared Spaces permit on behalf of Friends of Elm Alley to close Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday. Friends of Elm Alley has operated a daily weekday street closure in this location since April 2021. This application is a renewal from the previous year and proposes no changes to their closure footprint and setup. No objects are placed in the roadway other than barricades. The Elm Street Shared Space provides outdoor recreation area for schoolchildren during recess and lunchtime and facilitates a school bus loading and unloading area twice a day.

The Elm Street Shared Space is also known as "Elm Alley School Street", modeled after "school streets" in other cities around the world—a car-free space fronting a school to provide an outdoor play area and allow for the safe arrival and departure of schoolchildren. The Elm Alley School Street is a community-driven project funded through the Tenderloin Community Action Plan, which was led by SF Planning in collaboration with the Mayor's Office of Housing and Community Development, Office of Economic Workforce Development, Department of Public Health, Human Services Agency, United Way Bay Area, and community leaders and entrepreneurs in the Tenderloin.

The request is to close the following area to vehicular traffic, as requested by the applicant:

• Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday.

The SFMTA Board of Directors is asked to consider the approval of a Longer-Term Closure of the above area under the authority granted by California Vehicle Code section 21101 and Div. II, section 206 of the Transportation Code for the purpose of issuing a Roadway Shared Spaces permit. In doing so, the Board would find based upon a determination of public convenience and necessity that the subject portion of Elm Street is no longer needed for vehicular traffic during the proposed closure hours, and that the street closure is necessary for the safety and protection of the public who will use the street during the closure.

## **ITEMS**

The following item was considered at a Public Hearing held on November 14, 2024, by the Interdepartmental Staff Committee on Traffic and Transportation (ISCOTT).

A. ESTABLISH – SHARED SPACES ROAD CLOSURE – Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday.

Item A would grant a permit for a Shared Spaces Road Closure for United Way Bay Area on behalf of Friends of Elm Alley to provide a school street on Elm Street for Tenderloin Community School.

## STAKEHOLDER ENGAGEMENT

Item A was considered at a Public Hearing held on November 14, 2024, by ISCOTT. No public comments concerning these items were received at the hearing.

# **ALTERNATIVES CONSIDERED**

The details of the proposed closure presented in Item A are as requested by the applicant.

## **FUNDING IMPACT**

The ISCOTT application fee, which applies to Roadway Shared Spaces (Transportation Code SEC 6.16(g)), is set at a cost recovery rate to cover staff's time and effort to review the subject application. The applicant has paid an application fee of \$2,698 for applications submitted less than 30 days before the first event.

On April 19, 2021, the San Francisco Planning Department determined that the Shared Spaces Program (Case No. 2021-003010ENV), inclusive of Item A, is within the scope of the Better Streets Plan Final Mitigated Negative Declaration (FMND, Case No. 2007.1238E, September 17, 2010), and that the proposal would not require the preparation of a subsequent negative declaration under CEQA Guidelines section 15162. On October 28, 2010, the Planning Commission in Resolution No. 18211, adopted findings under the California Environmental Quality Act (CEQA), the CEQA Guidelines, and Chapter 31 of the Administrative Code (CEQA Findings), and a Mitigation Monitoring and Reporting Program (MMRP), associated with the Better Streets Plan.

Copies of the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors and may be found in the records of the Planning Department by Case Number at https://sfplanninggis.org/pim/ or 49 South Van Ness Avenue, Suite 1400 in San Francisco, and are incorporated herein by reference.

# OTHER APPROVALS RECEIVED OR STILL REQUIRED

Pursuant to section 206 of the Transportation Code, the decision of the SFMTA Board of Directors with respect to any proposed Longer-Term Closure of a Traffic Lane shall be final.

A public hearing for Item A was held at the November 14, 2024, meeting of ISCOTT.

The City Attorney has reviewed this item.

Staff recommends the Board approve the Roadway Shared Spaces street closure of Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday; and make environmental review findings.

# SAN FRANCISCO MUNICIPAL TRANSPORTATION AGENCY BOARD OF DIRECTORS

WHEREAS, The San Francisco Municipal Transportation Agency has received an application for a Roadway Shared Spaces street closure as follows:

A. ESTABLISH – SHARED SPACES ROAD CLOSURE – Elm Street between Van Ness Avenue and Polk Street, Tuesday, December 3, 2024, through Wednesday, December 3, 2025, 8 am to 4 pm, Monday through Friday; and,

WHEREAS, The subject portion of the above listed street is no longer needed for vehicular traffic during the proposed closure hours and the street closures are necessary for the safety and protection of the public who will use those portions of the street during the closures; and,

WHEREAS, On September 17, 2010, the San Francisco Planning Department published the Better Streets Plan Final Mitigated Negative Declaration (Better Streets Plan FMND, Case No. 2007.1238E), and under the California Environmental Quality Act (CEQA), the CEQA Guidelines, and Chapter 31 of the Administrative Code—the San Francisco Planning Commission adopted CEQA Findings, a Mitigation Monitoring and Reporting Program (MMRP) on October 28, 2010 under Motion 18211; and,

WHEREAS, On April 19, 2021, the San Francisco Planning Department determined that the Shared Spaces Program (Case No. 2021-003010ENV), inclusive of Item A is within the scope of the Better Streets Plan FMND and that it would not require the preparation of a subsequent negative declaration under CEQA Guidelines Sections 15162; and,

WHEREAS, The SFMTA Board of Directors has reviewed the Better Streets Plan Final Mitigated Negative Declaration (FMND) and Addendum and finds that since adoption of the FMND, no changes have occurred in the proposed project or in the circumstances under which the project would be implemented that would cause new significant impacts or a substantial increase in the severity of impacts identified and analyzed in the FMND, and that no new information has emerged that would materially change the analysis or conclusions set forth in the FMND; The actions approved herein would not necessitate implementation or additional or considerably different mitigation measures that those identified in the FMND; and,

WHEREAS, Copies of the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors, and may be found in the records of the Planning Department by Case Number at https://sfplanninggis.org/pim/ or 49 South Van Ness Avenue, Suite 1400 in San Francisco, and are incorporated herein by reference; and,

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it

RESOLVED, The San Francisco Municipal Transportation Agency Board of Directors adopts these CEQA findings as its own; a copy of the Planning Commission Resolution, the CEQA findings, and the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors, and may be found in the records of the Planning Department at <a href="https://sfplanning.org/">https://sfplanning.org/</a> and 49 South Van Ness Avenue, Suite 1400 in San Francisco, and is incorporated herein by reference; and, be it further

RESOLVED, That the San Francisco Municipal Transportation Agency approves Item A above and finds that the subject portion of the above listed street is no longer needed for vehicular traffic during the proposed closure hours and the street closure is necessary for the safety and protection of the public who will use that portion of the street during the closure.
