## May 1, 2015 PUBLIC HEARING RESULTS

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency held a public hearing on Friday, May 1, 2015, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the proposals listed below. This document summarizes the results of the hearing. Per Section 201 of the City Transportation Code, some items can be implemented by the authority of the City Traffic Engineer. Other items require further approval by the SFMTA Board.

#### 1. ESTABLISH – RED ZONE

Paulding Avenue, south side, from Raleigh Street to 24 feet easterly Paulding Avenue, south side, from Raleigh Street to 9 feet westerly

First item will be forwarded to SFMTA Board for approval and implementation; second item will be forwarded to City Traffic Engineer for approval and implementation.

#### 2. <u>ESTABLISH – TOW-AWAY NO PARKING ANYTIME, EXCEPT MARKED POLICE</u> <u>VEHICLES</u>

Grove Street, south side, from 91 feet to 135 feet west of Hyde Street (removes two yellow loading meters at #446-00001, spaces 7 and 9)

 $\implies$  Item will be forwarded to SFMTA Board for approval and implementation.

#### 3. ESTABLISH – TRAFFIC SIGNALS

- A. 19<sup>th</sup> Street at Dolores Streets (replaces one-way STOP control)
- B. 28<sup>th</sup> Avenue at Fulton Street (replaces one-way STOP control)
- C. 33<sup>rd</sup> Avenue at Fulton Street (replaces one-way STOP control)
- D. 37<sup>th</sup> Avenue at Fulton Street (replaces one-way STOP control)
- E. Columbus Avenue at Francisco Street (replaces two-way STOP control)
- F. Folsom Street at Mabini Street (replaces one-way STOP control)
- G. Russ Street at Howard Street (replaces one-way STOP control)

 $\implies$  Items will be forwarded to SFMTA Board for approval and implementation.

#### 4(a). ESTABLISH – NO PARKING ANYTIME

Kearny Street, east side, from Sacramento Street to 27 feet southerly (27-foot red zone) Sacramento Street, north side, from 6 feet to 20 feet easterly (20-foot red zone) Sacramento Street, south side, from 10 feet to 31 feet east of Kearny Street (31-foot red zone)


First and third items will be forwarded to SFMTA Board for approval and implementation; second item will be forwarded to City Traffic Engineer for approval and implementation.

### 10(a). ESTABLISH – TOW-AWAY NO STOPPING ANYTIME

- A. Franklin Street, east side, from Geary Street to 25 feet southerly (Extends existing red zone by 18 feet, Removes parking meter #1126)
- B. Franklin Street, west side, from Geary Street to 31 feet southerly (Extends existing red zone by 21 feet, Removes parking meter #1125)
- C. Geary Street, south side, from Franklin Street to 21 feet easterly (Removes parking meter #1139)

- C. 8<sup>th</sup> Street, east side, between Irwin Street and Hooper Street

- D. 16<sup>th</sup> Street, both sides, between De Haro Street and Rhode Island Street
- E. De Haro Stret, east side, between 15<sup>th</sup> Street and Berry Street
- F. Vermont Street, both sides, between 16<sup>th</sup> Street and 17<sup>th</sup> Street

#### 12(c). ESTABLISH – BUS ZONE (Option 2)

Newhall Street, west side, from 60 feet to 118 feet north of Hudson Avenue (removes 1 parking space)
