



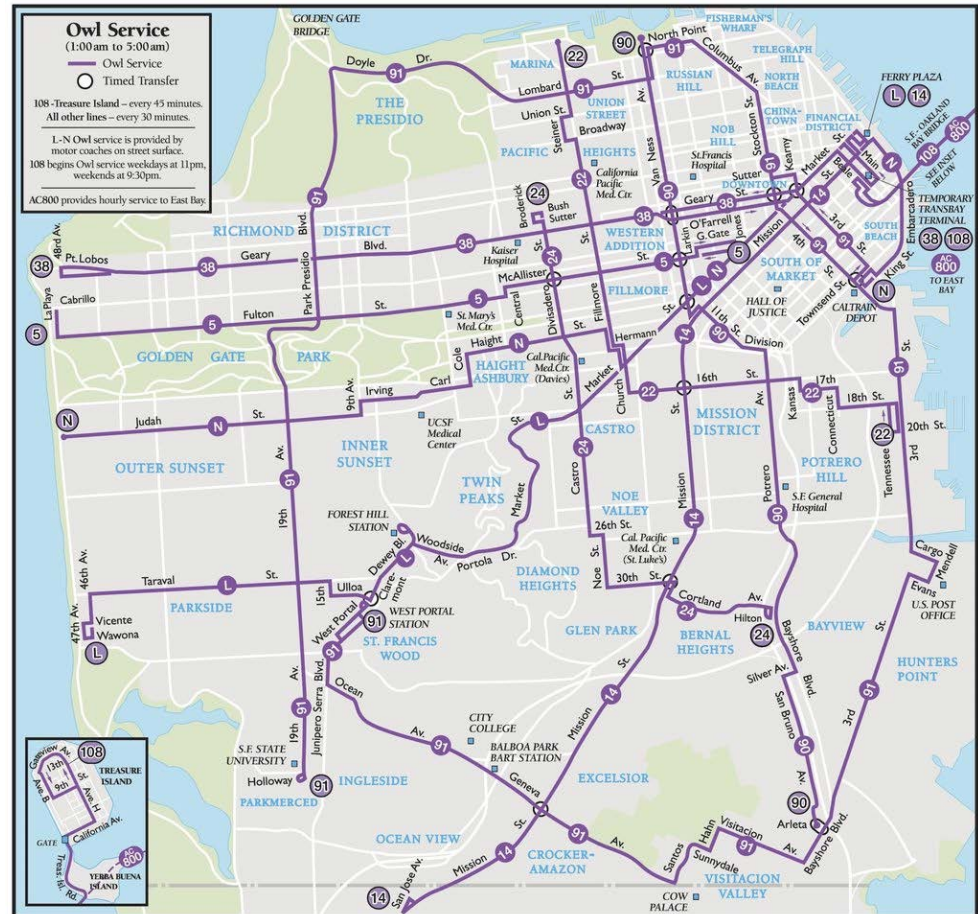

# Muni's Owl Network Strongest in the Region!

- 24 hour service on 8 routes, plus 90 and 91 Owl routes that cover sections of the T, 9, 28, 30, 49 routes
- Owl Network provides service from midnight-5:00AM, every 30 minutes within ½ mile walk of most residents



# Owl Service Key Needs

- **Reliability:** Need for travel time adjustments and dependable timed transfers
- **Frequency:** 25 Treasure Island does not meet our 30 minute service standard
- **Coverage:** Lack of access to Owl Network found in Mission/Potrero and Bayview/Hunters Point Neighborhoods
- Findings consistent with BOS sponsored Late Night Transportation Plan to improve regional late night transit service



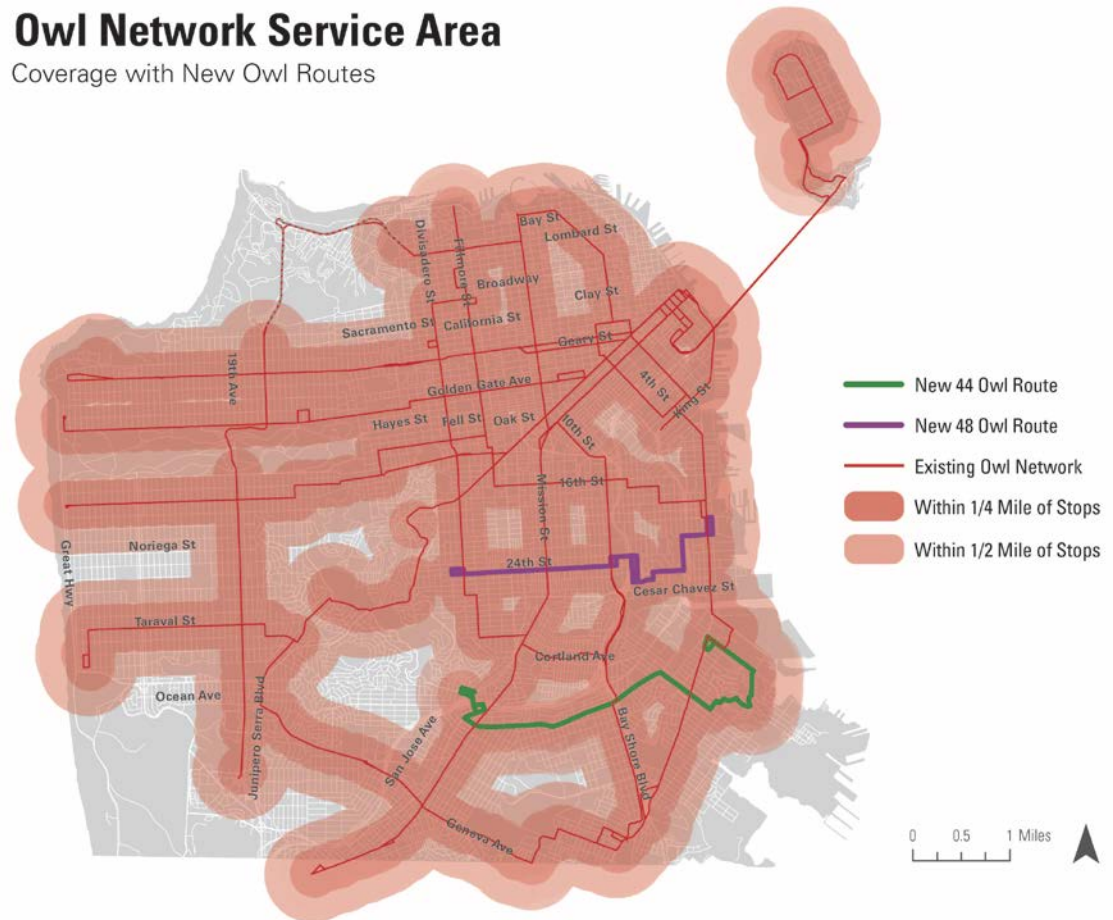


# Lifeline Grant Received to Support Improved Owl Service

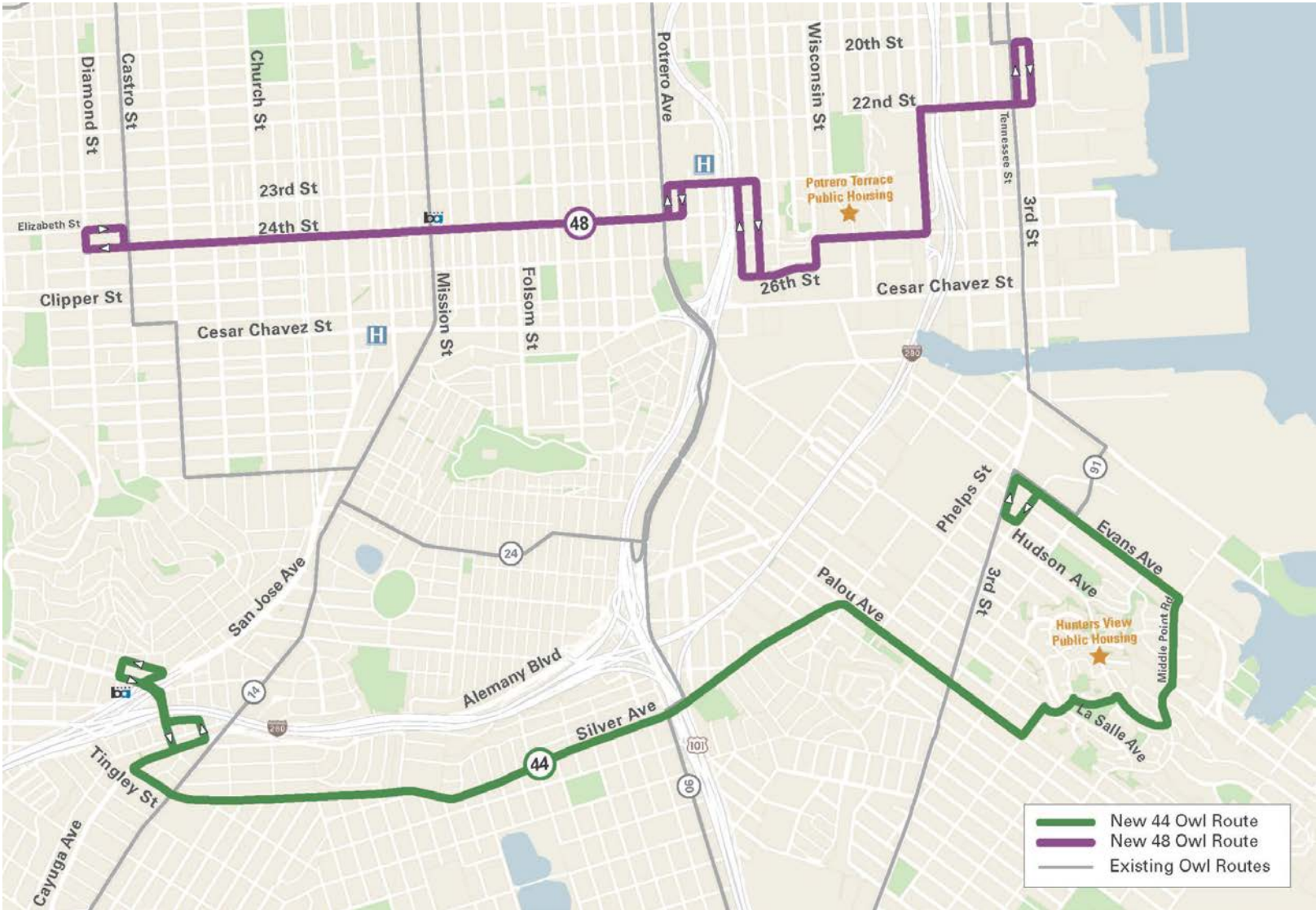
- **Reliability improvements:** Additional vehicle added to N Owl and 25 Treasure Island; schedule adjustments made to all owl routes.
- **Increased service:** Headways improved from 45 min to 30 min on the 25 Treasure Island
- **Improved coverage:** Two new routes added to improve access to the Owl network

These routes will connect to our other latenight services, providing greater 24-hour access to the entire city.

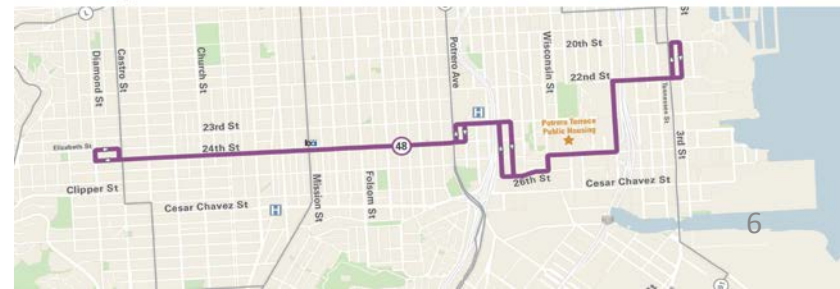

# Title VI – No Impacts Identified

- Title VI Service Equity Analysis required
- No disparate impact to minority populations or disproportionate burden to low income communities

% minority	58%	71%	51%	53%
% low income	51%	62%	28%	26%

Note: based on census, proposed changes have slightly lower benefit to low income households compared to citywide, but are still within the disproportionate burden threshold of 8%.
