#### STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

#### **DESCRIPTION**

Once approved by the SFMTA Board of Directors, the meeting schedule will be posted on-line and notice for all meetings will be posted in accordance with public meeting laws.

In addition to the proposed schedule of meetings below, additional special closed sessions will be schedule for conferences with the SFMTA's labor negotiator. The schedule for those special meetings has not yet been set.
