7. Presentation, discussion, and possible action regarding Comprehensive Rail/Transportation Plan, Subway Master Plan, Rail Capacity Study. (Grahm Satterwhite, Principal Planner, Sustainable Streets. Explanatory documents include a slide presentation.)

Grahm Satterwhite presented the item. He stated that the Long Range Transportation Plan is focused on near term and long term investments. Of the four high-priority near term investments, the top three were identified for funding. Long term investments were prioritized in three tiers.

He also discussed the Rail Capacity study and the current corridors that are operating over capacity. These include the Transbay corridor, the Sunset corridor, and the Richmond corridor. He stated that the significant overcrowding is a barrier due to operators and equipment and is not a capacity issue.

### **PUBLIC COMMENT:**

David Pilpel stated that the SFMTA should make the impact of the various projects clear to the public. The scenarios and choices should be laid out and trade-offs thoroughly explained. People should be more frustrated about the lack of movement on Geary. Some of the outreach has been inadequate. The SFMTA should challenge people more actively than they've done.
