March 18, 2016 PUBLIC HEARING RESULTS

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency held a public hearing on Friday, March 18, 2016, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the proposals listed below. This document summarizes the results of the hearing. Per Section 201 of the City Transportation Code, some items can be implemented by the authority of the City Traffic Engineer. Other items require further approval by the SFMTA Board.

1. ESTABLISH – BUS ZONE

California Street, south side, from 6th Avenue to 100 feet easterly

Item will be forwarded to SFMTA Board for approval and implementation.

2. ESTABLISH – SPEED HUMP

Topeka Street, between Silver Avenue and Quint Street (1 Speed Hump, making a total of two speed humps on this block)

 \implies Item will be forwarded to the City Traffic Engineer for approval and implementation.

3. ESTABLISH - SPEED HUMP

Quesada Avenue, between 3rd Street and Newhall Street (1 Speed Hump, making a total of two speed humps on this block)

 \Rightarrow Item will be forwarded to the City Traffic Engineer for approval and implementation.

4. <u>ESTABLISH – RESIDENTIAL PARKING PERMIT ELIGIBILIGY, AREA Q</u> 133 to 137 Baker Street (no signs to be installed)

Item will be forwarded to SFMTA Board for approval and implementation.

5. <u>ESTABLISH – RESIDENTIAL PARKING PERMIT ELIGIBILITY, AREA Q</u> 241 Central Avenue (no signs to be installed)

Item will be forwarded to SFMTA Board for approval and implementation.

6. <u>ESTABLISH – RESIDENTIAL PARKING PERMIT ELIGIBILITY, AREA U</u> 1330 Howard Street (no signs to be installed)

14. ESTABLISH – RADAR SPEED FEEDBACK SIGNS

- A. Panorama Drive, northbound, between Starview Way and Olympia Way
- B. Olympia Way, westbound, between Dellbrook Avenue (E) and Dellbrook Avenue (W)
- C. Clarendon Avenue, southbound, between Oak Park Drive and Panorama Drive
- D. Alemany Boulevard, northbound and southbound, between Victoria Street and Ramsell Street

 \implies Items will be forwarded to the City Traffic Engineer for approval and implementation.

15(a). <u>ESTABLISH – ABILITY FOR PERMITTED COMMUTER SHUTTLES TO USE MUNI</u> <u>BUS ZONE</u>

- A. Broadway, north side, from Grant Avenue to 100 feet westerly
- B. Columbus Avenue west side, from Broadway to 95 feet southerly
- C. 5th Street, east side, from Mission Street to 60 feet northerly

- A. Brannan Street, south side, from 77 feet to 135 feet east of 4th Street (restricts parking at 3 metered parking spaces)
- B. Gough Street, west side, from Grove Street to 80 feet southerly (restricts parking at 4 metered parking spaces)
- C. Oak Street, south side, from Steiner Street to 80 feet easterly (restricts parking at 3 unmetered, non-RPP parking spaces and 1 driveway)
- D. Fell Street, north side, from Laguna Street to 80 feet westerly (restricts parking through 2 parking spaces and 2 driveways)
- E. Dolores Street, east side, from 29th Street to 80 feet northerly (restricts parking at 3 RPP parking spaces and 1 driveway)

Item A has been withdrawn. Based on public comment received prior to the public hearing, items B, C and F have their afternoon restrictions withdrawn. Items D and E have their morning restrictions withdrawn. Staff will review public testimony received at the public hearing to determine if other changes may be recommended.

Broadway, north side, from Grant Avenue to 100 feet westerly (extends hours of parttime bus zone to 6 AM and 8 PM)

 \Rightarrow Item will be forwarded to SFMTA Board for approval and implementation.

15(e). ESTABLISH – TOW-AWAY NO PARKING, PERMITTED COMMUTER SHUTTLE BUS ZONE, 6 AM TO 10 AM, MONDAY THROUGH FRIDAY
