To approve various routine traffic and parking modifications.

ENVIRONMENTAL REVIEW

The proposed traffic and parking modifications are subject to the California Environmental Quality Act (CEQA). Title 14 of the California Code of Regulations Section 15301 provides an exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities.

The SFMTA, under authority delegated by the Planning Department, determined that the proposed traffic and parking modifications in Items A-O are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301. The proposed action is the Approval Action for Items B-O as defined by S. F. Administrative Code Chapter 31.

On October 22, 2015, the San Francisco Planning Department determined (Case Number 2015-007975ENV) that the traffic and parking modifications in Items J-N are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301 which provides an exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities, as well as Section 15308 which provides an exemption from environmental review for actions taken by regulatory agencies for protection of the environment.

The San Francisco Planning Commission certified the San Francisco Bicycle Plan Final Environmental Impact Report (Bicycle Plan FEIR) in June 2009. The Bicycle Plan FEIR reviewed the update to the City's Bicycle Plan originally adopted in 1997 in accordance with the California Environmental Quality Act (CEQA). The San Francisco Municipal Transportation Agency Board of Directors (SFMTA Board) and the San Francisco Board of Supervisors adopted the San Francisco Bicycle Plan, as well as related amendments to the San Francisco General Plan in 2009, and adopted findings under CEQA related to mitigation measures, alternatives, and a statement of overriding consideration. On May 7, 2013, the SFMTA Board of Directors in Resolution 13-054, re-adopted the 2009 Bicycle Plan (Case Number 2007.0347E), re-approved the traffic changes approved in Resolution 10-106, and adopted the modified findings, including a statement of overriding considerations and a mitigation monitoring and reporting program pursuant to CEQA.

The proposed traffic and parking modifications in Items P-Q were reviewed in the Bicycle Plan FEIR as part of Project 2-2: 5th Street Bicycle Lanes Market to Townsend Street.

Copies of the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors, and may be found in the records of the Planning Department at 1650 Mission Street in San Francisco.

WHEREAS, The proposed traffic and parking modifications are subject to the California Environmental Quality Act (CEQA); Title 14 of the California Code of Regulations Section 15301 provides an exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities; and,

WHEREAS, The SFMTA, under authority delegated by the Planning Department, determined that the proposed traffic and parking modifications contained in Items A-O are exempt from environmental review pursuant to Title 14 of the California Code of Regulations Section 15301; and,

WHEREAS, On October 22, 2015, the San Francisco Planning Department determined (Case Number 2015-007975ENV) that the traffic and parking modifications in Items J-N are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301 which provides an exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities, as well as Section 15308 which provides an exemption from environmental review for actions taken by regulatory agencies for protection of the environment; and,

WHEREAS, On May 7, 2013, the SFMTA Board of Directors in Resolution 13-054, readopted the 2009 Bicycle Plan (Case Number 2007.0347E), re-approved the traffic changes approved in Resolution 10-106, and adopted the modified findings, including a statement of overriding considerations and a mitigation monitoring and reporting program pursuant to CEQA, a copy of which is on file with the Secretary to the SFMTA Board of Directors and is incorporated into this Resolution by reference; and,

WHEREAS, The proposed traffic and parking modifications in Items P-Q were reviewed in the Bicycle Plan FEIR as part of Project 2-2: 5th Street Bicycle Lanes Market to Townsend Street; and,

WHEREAS, The proposed action is the Approval Action for Items B-O as defined by the S.F. Administrative Code Chapter 31; and,

WHEREAS, Copies of the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors, and may be found in the records of the Planning Department at 1650 Mission Street in San Francisco, and are incorporated herein by reference; and,

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors, upon recommendation of the Director of Transportation and the Director of the Sustainable Streets Division approves the changes.
