#### **PURPOSE**

To approve various routine parking and traffic modifications.

#### STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES:

#### ENVIRONMENTAL REVIEW

The proposed parking and traffic modifications are subject to the California Environmental Quality Act (CEQA). Title 14 of the California Code of Regulations Section 15301 provides an exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities. Section 15304 provides an exemption from environmental review for minor public alterations to land including the creation of bicycle lanes on existing rights-of-way. Section 15308 provides for exemption for actions taken by regulatory agencies, as authorized by state or local ordinance, to assure the maintenance, restoration, enhancement, or protection of the environment where the regulatory process involves procedures for protection of the environment.

The Planning Department has determined that the proposed parking and traffic modifications in Items A-L and N-Z are categorically exempt from CEQA (Planning Case Nos. 2017-009358ENV for Items A-L, 2015-007975ENV for Item N, 2017-001443ENV for Items O-R, 2017-001180ENV for Item S, 2017-009196ETM for Items T-Y, 2017-002111ENV for Item Z) pursuant to Title 14 of the California Code of Regulations Section 15301, Section 15304, and/or Section 15308. The proposed action is the Approval Action for Items A-L, Items O-R, and Items T-Z as defined by S.F. Administrative Code Chapter 31.

The Rincon Hill Plan Final Environmental Impact Report (Rincon FEIR) evaluated the environmental impacts of the proposed parking and traffic modifications in Item M. On May 5, 2005, the San Francisco Planning Commission in Motion 17007 certified the Rincon FEIR (Case No. 2000.1081E), and adopted findings including a statement of overriding considerations and a mitigation monitoring and reporting program pursuant to CEQA. No new significant effects have been identified, there is no substantial increase in significant effects already identified, and no new mitigation is required for the project. The SFMTA Board of Directors has subsequently reviewed the Rincon FEIR and CEQA Findings and adopts these findings as its own.
