7. Presentation, discussion, and possible action regarding update on the SFMTA Stationless Bicycle Share Program. (Heath Maddox, Senior Planner. No explanatory documents.)

Heath Maddox stated that the SFMTA has been working on bicycle sharing for seven years. The major expansion will begin this coming summer. There will be no excavation or mounting that happens. The new equipment will be modular and solar powered. The SFMTA has already issued the permits for the first phase of expansion. The stationless program will require changes to the transportation code and action by both the Board of Supervisors and the SFMTA Board of Directors. They will be going before the SFMTA Board on March 21st. The idea is to ensure that the stationless bike share system is done in a way that promotes public health. The SFMTA does not want sidewalks cluttered. The goal is to have equitable distribution of bikes throughout the city, maintenance of the public right of way, and to

regulate the quality and sturdiness of the bikes. Details of the permit are currently being created.

OCSC Motion 170309.01

The SFMTA CAC recommends that the SFMTA stationless bicycle permit program include regulations for bike safety codes, ensures that the bicycles don't block the public right of way, and include a plan for enforcement.

8. Presentation, discussion, and possible action regarding the On-Street Car Share Parking Permit program. (Andy Thornley, Senior Project Analyst. Explanatory documents include a slide presentation.)

Andy Thornley stated that the program reduces the number of private vehicles, reduces congestion and emissions, and relieves parking demand. This item is scheduled to go before the SFMTA Board in May 2017.
