

Appendix I

SFMTA Taxi Driver Fund Survey

The Survey was sent by direct e-mail to 3,695 drivers. 504 respondents completed the Driver Fund Survey. 81% chose to rank the proposed recommendations, while 19% elected to submit an alternative recommendation.


Of the 81% who chose to rank the proposed recommendations, waiving the Driver's annual A-card renewal fee was the preferred recommendation.

98 alternative recommendations were submitted



Number -	Medallion related Payments and Assistance
