Ed Reiskin, Director of Transportation, presented the Strategic Plan report.

Edward Mason discussed Muni-related crimes and asked if there was a way to show the absolute number.

• Polk Streetscape Project

Luis Montoya, Livable Streets, reviewed the Polk Street Streetscape project options.

#### PUBLIC COMMENT:

Dale Mortensen stated that doctors are concerned about the loss of parking, especially for elderly or disabled patients.

Phoebe Douglas stated that cyclists have to watch for car doors, cars and potholes, not to mention speeding cyclists. She would like to see a separated bikeway. While she understands the merchants' concerns, she added that everyone has to adapt. She prefers option C and noted that the impact of the Van Ness Bus Rapid Transit project on Polk St. needs to be discussed.

David Curiel stated that he rides to his work on Polk St. every day and does all of his shopping on Polk Street. Merchants need to know that cyclists support Polk St. merchants. He noted that he feels vulnerable on Polk St. every day and urged the committee to consider the safety of having a separate cycle track.

Edward Mason asked about the cost differential for paving Polk St. versus adding other amenities. He also inquired as to the funding mechanism.

Stephanie Chang discussed the need to accommodate those who drive. Parking is already extremely difficult or nearly impossible and it makes people late for medical appointments. There also needs to be accommodation for people coming from outside the neighborhood and/or city. Neighbors walk, use transit or cycle. Taking one lane of parking eliminates parking by 50 percent.

Kelly McCune urged the committee to support strong safety alternatives for pedestrians and cyclists.

Dawn Trent discussed moving parking on streets within one block of Polk St. Parking is okay if the street is flat but often they are steep which makes parking difficult. The grade of the street isn't shown in diagrams.

Winston Parsons stated that the design of public roads impacts everyone. The SFMTA should have a broad lens to consider others in the region and the impact on future generations. Often opposition is based on the fear of change.

Julie Kirschbaum, Manager, Operations Scheduling and Service, presented the item.
