ORDER OF BUSINESS

1. Call to Order

Vice Chairman Heinicke called the meeting to order at 1:00 p.m.

2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Vice Chairman Heinicke announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

4. Approval of Minutes

No public comment.

On motion to approve the minutes of the September 5, 2017 Regular Meeting: unanimously approved (Brinkman-absent).

5. Communications

Board Secretary Boomer stated that Items 13 and 14 had been removed from the agenda at the request of staff.

Chairman Heinicke asked that the meeting be adjourned in memory of Terry Smerdel, a San Francisco Fire Department Battalion Chief.

6. Introduction of New or Unfinished Business by Board Members

Director Borden inquired about the impact of the Central Subway Project (and other major capital projects) on small business. Director Reiskin provided an overview.

Vice Chairman Heinicke asked staff to report back regarding the idea of setting a flat fee from the City to the Airport for a taxi ride.

7. Director's Report (For discussion only)

-Update on Vision Zero -Ongoing Activities

Ed Reiskin, Director of Transportation, discussed safety and Muni Mobile ads; status of state legislation; the Cable Car Gearbox Rehabilitation Project; installation of new fareboxes; Transit Week; and the impact of capital projects on business.

No public comment.

8. Citizens' Advisory Council Report

No report.

9. Public Comment

Nima Rahimi discussed private transportation vehicle regulations. Chariot and the SFMTA have been working collaboratively and have made progress. Chariot reached a negotiated collective bargaining agreement with the Teamsters that was ratified by the employees yesterday. They welcome the additional time.

Jerome Molles discussed a space for rent in a downtown SFMTA garage. He would like to be considered for the space.

Aleta Dupree discussed fares and cable cars. She read the report about the cash audit on cable cars and expressed support for removing cash from the cable cars given the evidence in the audit. London Transit is now a cashless system as are other European cities. This is a doable but the agency needs courage and leadership. The evidence shows that we can do a cashless cable car system with the installation of inexpensive technology. This will be safer and more efficient.

Michael Thompson expressed appreciation for moving the private transportation vehicle items to the next meeting.

Richard Rothman stated that he is frustrated dealing with the Sustainable Streets Division. It needs to be re-organized. Someone needs to be responsible for each section of the city. In 2012, Public Works made 38th and Balboa unsafe. It took six years to get something done. The people in that area want stop signs. This is a busy intersection corridor and some parts are high injury areas. There are two people at the SFMTA who don't want to approve it. There was an accident on Fulton and 43rd in 2011 and the SFMTA still hasn't made any major changes. Residents asked for speed humps and signs but the SFMTA said no.

Emily Loper discussed private transit vehicle regulations. Transportation is the #1 concern of Bay Area residents. She expressed support for private transportation vehicle services as they help fill gaps in the public transportation system.

Herbert Weiner stated that there is a danger posed by bicycles on the sidewalk. There is a historical precedent for this. People used to smoke on the bus, including pot. That problem was resolved.

Bikes on the sidewalks is solvable too. Parking Control Officers aren't needed on every corner. When people get cited, the word gets out and the activity stops. Nobody wants to bet hit by a cyclist on a sidewalk.

Tom Gilberti stated that people are riding scooters on the sidewalk along the Embarcadero. The platform door, railing and elevator at the Civic Center station is filthy and likely toxic. The platform and elevator needs to be steam cleaned every two weeks. The Powell St. station was clean but someone had urinated against a wall and he couldn't take his wheelchair through the puddle. If an elevator can't be fixed, the entire station should be closed. The new elevators should be right in the stations instead of having them a block away.

<u>California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31</u>: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
