## Dear Resident:

At its January 16, 2018 meeting, the SFMTA Board of Directors approved the establishment of Residential Parking Permit (RPP) Area AA, Northwest Bernal Heights. You are receiving this letter because you live or own a business within this area. You may be eligible to purchase an Area AA parking permit, if:

- 1) You are a resident of Area AA and have a motor vehicle registered in your name at your address, or
- 2) You own or lease commercial property and actively engage in business within the approved area (see attached rules for obtaining an RPP Permit, Rule # 6).

Residential Parking restrictions will not become effective before June 16, 2018. In May, SFMTA will be installing the RPP signs that will read, "2-Hour Parking, Monday - Friday, Except Vehicles with Area AA permits." Please be assured that though the signs may be installed earlier, the RPP restrictions will not be enforced until after June 16.

The annual Residential Parking Permit fee is \$128.00 if purchased before June 30, 2018. The price increases to \$136.00 if purchased on or after July 1, 2018. The first permit will be valid until October 31, 2019 (about 15 months). Thereafter, permits will be renewable for one year. Renewal notices will be mailed automatically to all existing permit holders two months prior to the date of expiration.

In Area AA, persons will be limited to one permit and households will be limited to no more than two permits. Permits for in-home medical or child care workers are exempt from the household limit. Waivers of the household limit will be made if there are additional drivers and there is available parking in the area. Please visit <u>www.sfmta.com/rpp</u> for applications and instructions.

An application and instructions for completing it are enclosed for your convenience. Please mail in the completed application along with payment and required documents as soon as possible. AA permits will not be issued in person at the Customer Service Center. All applicants must mail their applications. Allow up to three weeks for processing. Permits will be mailed only to the permit address.
