In 2021, the SFMTA implemented temporary changes to assist the 43 Masonic and 44 O'Shaughnessy on segments of Presidio, Masonic and Woodside Avenues as well as Laguna Honda Boulevard and Bosworth Street. And a majority of those who took our evaluation survey support maintaining these transit lanes and other improvements. Based on these positive results, the SFMTA is proposing to make most of these changes permanent.

Proposed for permanent implementation:

**Conversion of temporary transit lanes to permanent transit lanes on Presidio Avenue:**

Southbound, for one block from Euclid to Sutter streets

**Conversion of temporary transit lanes to permanent transit lanes on Masonic Avenue:**

Southbound, for one block from Fell to Oak streets

**Conversion of temporary transit lanes to permanent transit lanes on Bosworth Street:**

Westbound from Lippard to Elk streets

**Conversion of temporary left turn restrictions to permanent left turn restrictions on Masonic Avenue:**

- Northbound and southbound at Page, Hayes, Grove, Fulton streets and Golden Gate Avenue
- Northbound at Turk Boulevard
