- Mission Bay Parks Transition to Rec & Park
 - Samuel Thomas discussed the transition of Mission Bay Parks to Rec & Park.
 - Park patrol will serve as the enforcement wing for the parks.
 - Important Points: Emphasis on the role of park patrol in the new structure.

Action Items: Further discussions with REC and PRT staff in attendance planned for future meetings.

4. Fehr & Peers preliminary report and potential key findings (For discussion and Possible Action)

- Mike Hawkins presented the preliminary report.
- Discussed mode share, focusing on auto mode share being higher than the target.
- Public transit mode share fluctuates and is higher for Warriors events compared to concerts.
- Concerns raised about auto mode share exceeding targets.
- More MTAP staff could be useful in implementing crowd control
- Adding PCOs to smaller events could help with traffic management

Committee Comments:

Member Sharpe expressed concern with changing time of use patterns with more to do around the arena.

Attendees stay longer after certain events with more amenities available. There is a difference from weeknight events and weekend events.

Member Kothari asked for more info on how the community is being impacted and how to interpret the data.

Member Hawkins responded that more detail will be provided in the full report along with additional strategies to influence a reduction in auto mode split.
