FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, September 6, 2013 at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

**ESTABLISH – PASSENGER LOADING ZONE, 7AM TO 10PM, DAILY**

277 Golden Gate Avenue, south side, from 0 feet to 38 feet east of bus stop, removing meters 241 and 239 (38-foot zone)

**ESTABLISH – PASSENGER LOADING ZONE, 7AM TO 10PM, DAILY**

38 Dolores Street, west side, from 0 feet to 52 feet south of the north end of bulbed-in area (52-foot zone)

**REVOKE – METERED LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH SATURDAY**

600 14<sup>th</sup> Street, north side, from 35 feet to 57 feet, and from 77 feet to 95 feet west of Dolores Street, at parking meter stalls 606 and 610 (40-feet total)

**ESTABLISH – METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH SATURDAY**

600 14<sup>th</sup> Street, north side, from 5 feet to 49 feet west of the east property line, at new parking meter stalls 600 and 602; and from 2 feet to 24 feet west of the west driveway at new parking meter stall 612 (66-feet total)

**REVOKE – FIVE (5) METERED MOTORCYCLE PARKING STALLS**

178 Townsend Street, north side, from 10.5 feet to 28 feet east of Clarence Place, motorcycle meter spaces 172, 174, 176, 178 and 180 (17.5-foot zone)

**ESTABLISH – FIVE (5) METERED MOTORCYCLE PARKING STALLS**

3 Clarence Place, east side, from 20 feet to 40 feet north of Townsend Street, replacing parking meter space #3 (20-foot zone)

**ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 5PM TO MIDNIGHT, TUESDAY THROUGH SATURDAY, WHEN VALET IS PRESENT**

178 Townsend Street, north side, from 10.5 feet to 50.5 feet east of Clarence Place, at new parking meters 172 and 170 (40-foot zone)

**ESTABLISH – PASSENGER LOADING ZONE, AT ALL TIMES**

1190 Mission Street, north side, from 0 feet to 26 feet and 36 feet to 88 feet east of parking meter stall 1180 (78-foot zone)

Public hearings are held once a month at City Hall to legislate the installation of new colored zones. The zones usually recommended for this process are blue, green, white, and yellow. The purpose of the hearing is for residents to express their concerns regarding proposed changes affecting their streets. All interested parties are encouraged to attend. At the Public Hearing, the Hearing Officer will review the items and listen to residents, then make a final decision. Upon approval and payment of any applicable installation fees, zones will be installed as soon as scheduling permits.
