Directors Heminger, Kirschbaum, Cajina, Henderson, and Tarlov provided remarks in appreciation of Director So.

Julie Kirschbaum, Director of Streets, introduced Bree Mawhorter, Chief Financial Officer, to recognize the staff from the Payroll Unit and Kimberly Ackerman, Chief People Officer to recognize staff from the Peer Assistance Program (PAP) and Employment Services Unit.

Director Kirschbaum, acting on behalf of the Director of Transportation, provided an update on Twin Peaks Tunnel work, shared about a new General Obligation (GO) Bond, Bike and Roll to School Week, Earth Day, and a recent Administrative Professionals Day luncheon.

Director Henderson requested to learn more about the PAP program, at a board meeting or briefing.

PUBLIC COMMENT:

Michael Petrellis expressed concern about the proposed GO Bond and Vision Zero, also sharing concern about the delay of changes at West Portal.

Luke Bornheimer commented on the GO Bond and climate action.

Herbert Weiner expressed concern about Vision Zero being an impossible goal to achieve and suggested working with the police department.



Allan Buradell expressed concern about Vision Zero, sharing that more enforcement is needed by the police department.

8. Citizens' Advisory Council Report

Aaron Leifer, Citizens' Advisory Council (CAC) Chair, presented the report.

PUBLIC COMMENT:

Luke Bornheimer thanked the CAC for supporting the Friday Kahlo Way and West Portal improvements and urged the SFMTA to take action on the West Portal project.

Speaker expressed concern about the Frida Kahlo Way vote at the CAC and shared that the concerns raised were comparable to the concerns of citizens.

Jess Win shared about being a student at City College and expressed concern regarding the Frida Kahlo Way Quick-Build Project.

Harry Bernstein expressed concern about recent efforts at West Portal, sharing that that there was a great amount of community interest.

Michael Petrelis expressed concern for the fatalities at West Portal and called for a moment of silence for the family and everyone that has died on San Francisco streets.

Michael Petrelis expressed concern about potholes in the city and pedestrian hazards at Jane Warner Plaza.

Herbert Weiner expressed concern regarding paratransit wait times and commented on Vision Zero and sidewalk safety from bicycles and scooters.

Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
