1) Call to Order

4) Acceptance of the Agenda

6) Public Comment

Ms. Brown announced that MTC is looking for participants in a study that aims to improve Bay Area transit signage.

Mr. Haagsman announced that Muni service changes will go into effect on August 17, 2024. Information about the changes is on the SFMTA website.

Chairman Glock requested a presentation on service changes at the August 15, 2024 MAAC meeting.

7) Business of the Afternoon:

A) M Oceanview Transit & Safety Project

Project Manager Jessica Kuo introduced the Muni Forward project to improve transit reliability, safety and accessibility on the M Oceanview line.

SFMTA recently was awarded a federal All Stations Accessibility Program grant to construct 3 new accessible platforms on the M line. New platforms will be constructed

at 19th Ave. & Randolph (north)/19th Ave. & Monticello, and at San Jose Ave. at Niagara.

A quick build boarding island was installed on San Jose and Niagara in July. Additional quick build elements will be constructed in 2025. Detail design of the accessible platforms is underway and full construction will begin in 2026.

Ms. Brown asked how people who are blind will use the new island. Ms. Kuo said detectable tile will be added to the edge of the island.

Mr. Fischer asked if a ramp would be constructed at San Jose and Niagara. Ms. Kuo reiterated that the accessible ramp will be constructed in the future and that the quick build island is still an improvement because it provides a safer place to alight than the current stop configuration.

Ms. McAuliff expressed appreciation for Ms. Kuo's coordination with Accessible Services to improve accessibility on the M line.

B) MAAC Goal Setting Discussion
