**Resolution amending Section 310 of Division II of the San Francisco Transportation Code by adding fines for failing to install a passenger information monitor in every taxi, retaliating against a driver for establishing, or not establishing, his or her own credit card processing account, refusing to allow passenger to choose among available fare payment systems, retaliation against a permit holder for exercise of a right granted by Article 1100 of Division II, misconduct relating to acceptance of paratransit debit cards, tampering with vehicle equipment, failure to make required notices or supply required information to paratransit broker, and failure to supply security camera data to SFMTA or SFPD.**

The Municipal Transportation Agency Board of Directors of the City and County of San Francisco enacts the following regulations:

Section 1. Article 300 of Division II of the Transportation Code is hereby amended by amending Section 310, to read as follows:

**Sec. 310. SCHEDULE OF FINES.**

Violation of any of the following subsections of the San Francisco Transportation Code governing the operation of a motor vehicle for hire shall be punishable by the administrative fines set forth below.




