The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, June 15, 2018, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

1. **ESTABLISH – BUS ZONE**

Broadway, south side, from 20 feet to 170 feet west of Van Ness Avenue (removes 8 parking spaces) (Supervisor District 2)

2. **ESTABLISH – RAISED CROSSWALK**

California Street, south side, at Orben Place (Supervisor District 2)*

3. **ESTABLISH – RESIDENTIAL PERMIT PARKING ELIGIBILITY, AREA U**

1009 Howard Street; no signage changes (Supervisor District 6)

Tennessee Street, east side, between 19th Street and 20th Street (Supervisor District 10)

Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.
