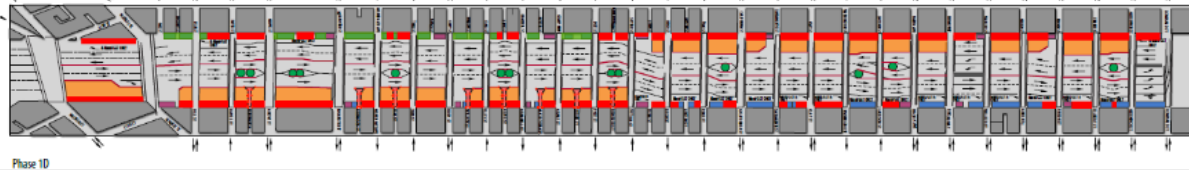
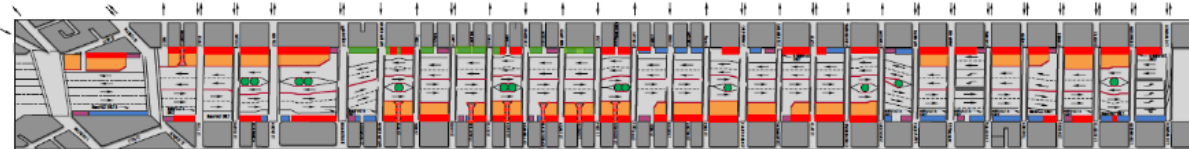


Project Schedule

- Phases 1C and 1D underway. Expected completion summer 2020

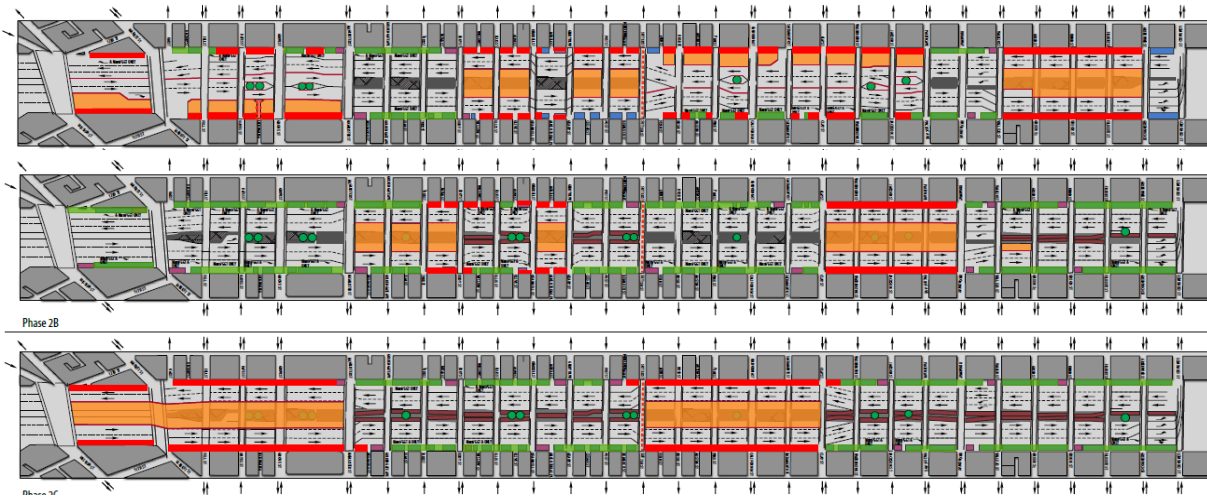

Construction Update

- **City and County of San Francisco's Public Health Order**
 - Essential infrastructure projects continue
 - Includes Van Ness Improvement Project
 - Considered vital as it is replacing aging utilities essential for operation
 - Due to low daytime traffic volumes reducing roadway to one lane for some work
 - Allows work to be shifted to daytime
 - Reduces burden on neighbors sheltering-in-place
 - SFMTA continues to monitor projects as the situation develops

Staff Updates

Project contract modification to MTA Board

- Tuesday, May 19, 1:00 p.m.
- Authorizes an increase to the contract for additional sewer, water, power, sidewalk and scheduling services required by design changes for field adjustments.
- Covered by project's allocated allowances, does not increase project budget or duration
 - Increases the contract amount by \$2,170,132.83

Neighboring Project Updates

Geary Rapid Project

The first phase of construction as part of the [Geary Rapid Project](#) continues. Work to replace aging water and sewer lines between Masonic Street and Van Ness Avenue is scheduled to be done in coordination with the San Francisco Public Utilities Commission (SFPUC).

The Lombard Street Vision Zero Project includes constructing pedestrian safety and transit performance enhancements as well as utility improvements on US 101 (Lombard Street at Richardson Avenue) between Francisco Street and Van Ness Avenue.

- Project completion scheduled June 2020. CalTrans to repave the roadway at a later date.
