FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, July 25, 2014 at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

REVOKE – METERED MOTORCYCLE STALLS

50 Fell Street, north side, from 122 feet to 164 feet east of Van Ness Avenue (12 spaces, meter stalls # 26, 28, 30, 32, 34, 36, 38, 40, 42, 44, 46 and 48 to be replaced by a part-time passenger loading zone described by the next item below)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7AM TO 9AM, 11:30AM TO 12:30PM, AND 3PM TO 6PM, MONDAY THROUGH FRIDAY

50 Fell Street, north side, from 0 feet to 126 feet west of meter stall #16 at parking meter stalls number 18, 22, 24, 26, 28 and 30 (126-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 11AM TO 2PM AND 6PM TO 11PM, MONDAY THROUGH SATURDAY, AND 10AM TO 11PM, SUNDAYS

123 2nd Street, east side, from 0 feet to 21 feet north of Minna Street, at meter stall #115 (21-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7AM TO 10AM AND 3PM TO 6PM, MONDAY THROUGH FRIDAY

250 10th Street, west side, from 0 feet to 44 feet north of parking meter stall #234, at parking meter stalls #232 and #230 (44-foot zone)

ESTABLISH – PASSENGER LOADING ZONE, AT ALL TIMES

"498" China Basin Street, north side, from 0 feet to 20 feet east of 3rd Street crosswalk line (20-foot zone)

ESTABLISH – BLUE ZONE

500 Felton Street, north side, from 0 feet to 20 feet west of west crosswalk line at Hollyoke Street (20-foot zone)

ESTABLISH – PASSENGER LOADING ZONE, DURING RECREATION CENTER HOURS

"590" Felton Street, north side, from 69 feet to 96 feet east of Hamilton Street (27-foot zone)

EXTEND – YELLOW METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY

549 Hayes Street, south side, from 0 feet to 24 feet west of meter stall #517 (existing 23-foot yellow zone at parking meter #517 would be extended by an additional 24feet at parking meter #519)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 5PM TO 1AM DAILY

584 Valencia Street, west side, from 0 feet to 40 feet north of meter stall #552, at parking meter stalls #552 and #550 (40-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7AM TO 7PM, MONDAY THROUGH FRIDAY

680 Folsom Street, north side, from 0 feet to 62 feet east of meter stall #660, at meter stalls #658, #656 and #654 (62-foot zone)

EXTEND – PART-TIME PASSENGER LOADING ZONE, 9:30PM TO 4AM, TUESDAY THROUGH SATURDAY

1015 Folsom Street, south side, from Harriet Street to 26 feet easterly (26-foot extension to existing 52 foot long zone)

ESTABLISH – BLUE ZONE

1035 Chenery Street, south side, from 14 feet to 36 feet east of Elk Street (22-foot zone)

ESTABLISH – PASSENGER LOADING ZONE, 7AM TO 10PM DAILY

1155 Jones Street, west side, from 0 feet to 20 feet north of driveway (20-foot zone)

REVOKE – PASSENGER LOADING ZONE, AT ALL TIMES

ESTABLISH – SHUTTLE BUS ZONE, 7AM TO MIDNIGHT, MONDAY THROUGH SATURDAY, AND 7AM TO 9PM SUNDAYS

1727 Lombard Street, south side, from 0 feet to 25 feet east of the west driveway (25-foot zone)

ESTABLISH – GREEN ZONE 9AM TO 6PM, MONDAY THROUGH SATURDAY

2275 Revere Avenue, west side, from 0 feet to 18 feet north of driveway (18-foot zone)

REVOKE – YELLOW LOADING ZONE, 8AM TO 4.30PM, MONDAY THROUGH FRIDAY

2600 Harrison Street, west side, from 30 feet to 63 feet north of the south property line (33-foot zone)

ESTABLISH – GREEN ZONE 9AM TO 6PM, MONDAY THROUGH SATURDAY

4214 Mission Street, west side, from 0 feet to 22 feet north of the south property line (22-foot zone)

Public hearings are held once a month at City Hall to legislate the installation of new colored zones. The zones usually recommended for this process are blue, green, white, and yellow. The purpose of the hearing is for residents to express their concerns regarding proposed changes affecting their streets. All interested parties are encouraged to attend. At the Public Hearing, the Hearing Officer will review the items and listen to residents, then make a final decision. Upon approval and payment of any applicable installation fees, zones will be installed as soon as scheduling permits.
