BACKGROUND INFORMATION / COMMENTS

Stations with bicycles are 6 feet wide and 4 feet tall with a kiosk 7.8 feet tall and map panel at the northern end of the station. Stations are solar powered via a panel system that extends vertically from the kiosk. No excavation is necessary.

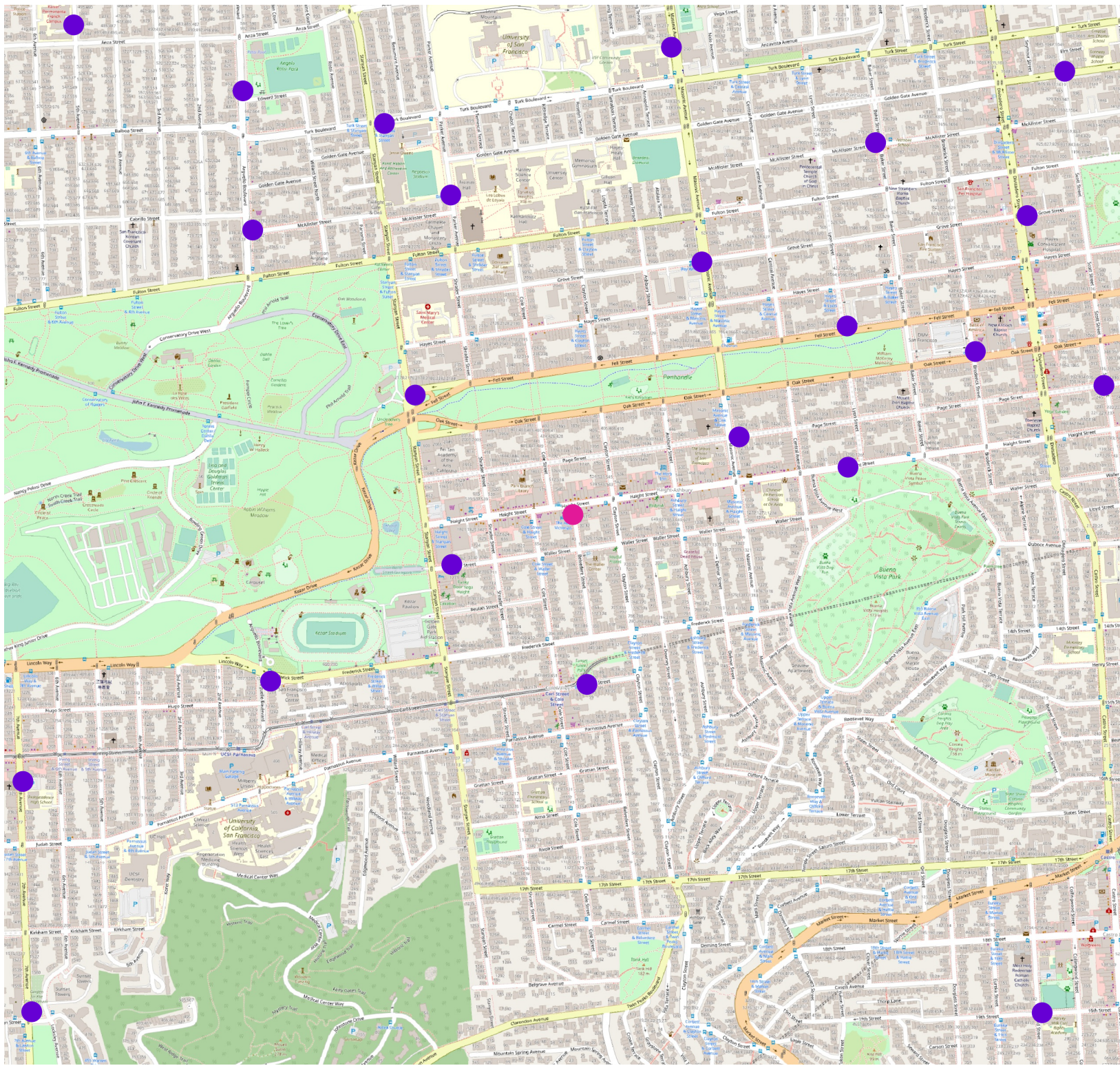

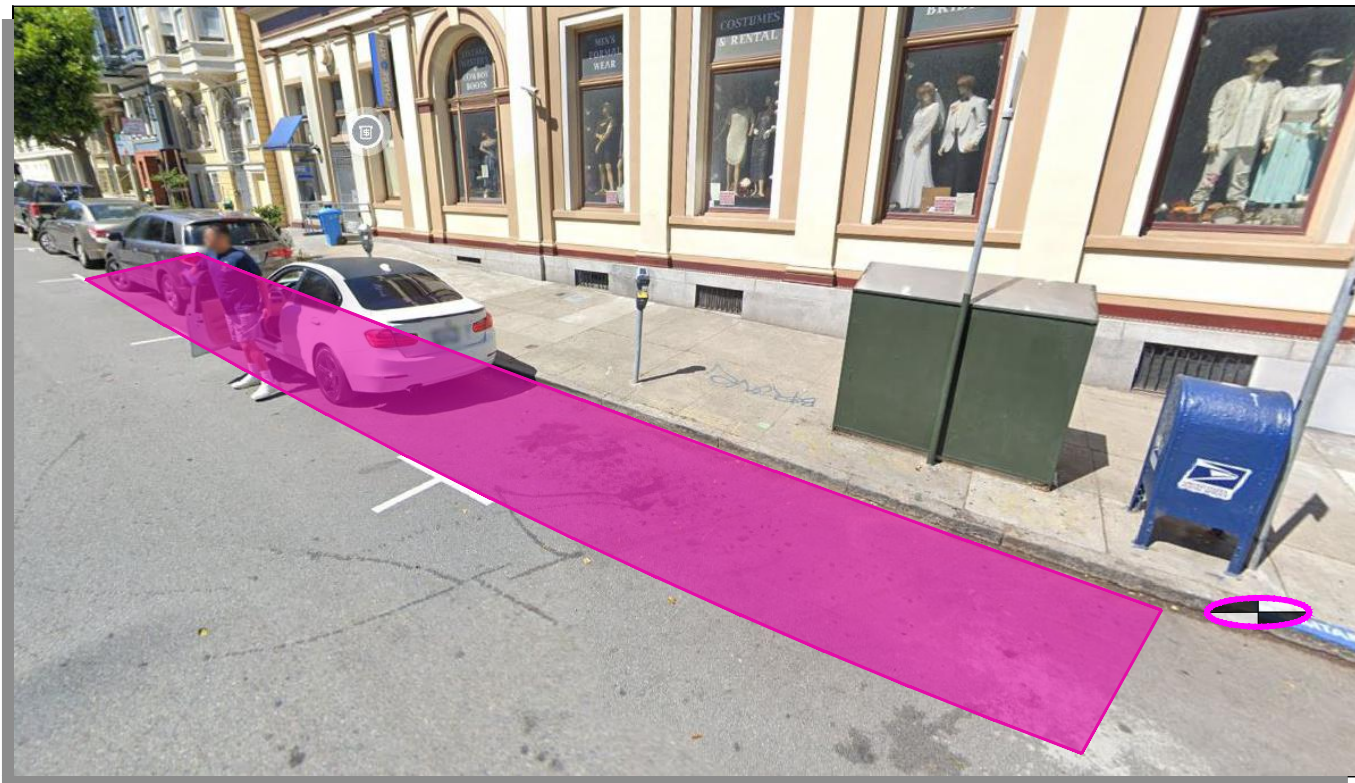

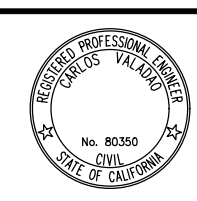

Hi Steven,

The Supervisor hasn't outright stonewalled. But, they are keeping HAMA close to the discussion, and that group is saying it is a non-starter.

In the most recent meeting, HAMA said NOT on Haight, either Page or Waller instead. And even proposed Waller and Belvedere. They also said that Bay Wheels should rent a storefront instead of taking up parking. I tried to explain this was not a feasible model, but they didn't seem to accept that logic, pointing to laundromats.

A Haight/Cole or Belvedere location makes good transportation sense. It would convert metered parking, instead of residential, which is priced to provide availability, and it would be in the heart of the commercial area, which is where the system should be placed.

It could be good to get MTA and CVIA on the same page. We have not backed off of the idea of having a station on Haight and Cole or Belvedere, but we haven't found the path forward yet. Let me know if you want to put heads together for next steps.

I am happy to provide some pics of how and where stations are installed on various widths of sidewalks but you're in this business heavily so I'm sure you know. We shouldn't have to make a case out of this considering these facts. There is nothing different or specific about SF from, say, Oakland with regards to sidewalks and station installations. You have done it in a modicum of locations but compared to Oakland, upsidedown.

Again, the real question is the metrics of whether the neighborhood actually need more bikes physically or has it reached capacity on # of bikes & availability.

Hello Bruce, Christin and Lisa,

I'm consolidating your replies below. I really appreciate the thoughts and coordination on this.

From Christin, it sounds like SFMTA is checking to see if HANC wants to provide time for bikeshare to present the proposal at their November 10 meeting.

If HAMA has a standing meeting you'd like us to attend between now and Dec 2, please let me know.

From Bruce, thanks for sharing your observations on bikeshare around the Bay. The Bikeshare Program consistently pushes up against opposition to parking conversion. We've actually tried very hard to put bikeshare stations in locations that minimize parking impact. Although, this has its own challenges and consequences.

For challenges, if sidewalks aren't wide or long enough, we can't locate a station where it might block access/egress, or the path of travel according to strict ADA requirements. We're also cautious to avoid fronting on windows. In some places, we've attempted to place them on sidewalks at an angle in order to reduce the footprint width, but that makes the station longer, which requires more length along a building face to be unobstructed. For consequences, we've seen how sidewalk stations make trips start or end on sidewalks, and it can lead to users riding bikes on sidewalks, which is less than ideal for comfortable sidewalk conditions for pedestrians. I feel like—after many years—the city has normalized bikes on the street, not the sidewalk, and keeping bike riding off them should continue to be our goal.

In regard to parking conversion, congestion, and modeshift, the city continues to densify, and without alternative options, people will continue to drive, leading to more congestion and competition for parking. The only way to facilitate more trips, both resident and visitor trips like Haight is known for, we need more options. Fortunately, with priced parking, the goal is to facilitate better turnover and usage of the curb space. This in conjunction with bikeshare are part of the overall efforts to provide people with multiple options. Without a bikeshare station here, we can't do that.

I think Neal linked the data dashboards we have for bikeshare. If you need to drill into it more, please go for it. Keep in mind how we have concrete data for system growth, and we also understand how gaps in the network affect usage and service. I personally live near a station on the edge of the

network, and it leads to complicated rebalancing needs. This Haight/Belvedere location fills a gap and has the potential to serve the neighborhood with a real bikeshare option, in addition to the current success.

Thank you for the cogent and detailed update. We do look forward to meeting with you. Will get a date for you very soon.

I would note that your statement, "*Also to keep in mind, station data is only part of the answer. With stationless bikes, the ridership to the Upper Haight is larger than just station activity.*", doesn't include the number of bikes used or available in this geographic area. Usage is only part of the story in data analysis so let's not get ahead of our handlebars 😊 .

Let's dig a little deeper into the metrics to emerge some more results as to the exact quantity for bikes or if the repetitive use of the current bike stock is enough to sustain community use. Ultimately, the correct balance and ratio of use versus bike stock is paramount for all involved.

That said, we need to have some serious discussion about placement of the bike stations, no less, . The majority of practice around the Bay Area is on the sidewalk or off-street. I travel the Bay Area significantly every week(end). It is a rare

occasion to see these large bike stations on the street, no less, this type that much anymore.

With SFMTA incrementally removing street parking in a dense residential areas there doesn't seem to be any effect of dissuading people to stop using personal vehicles or demand for purchasing personal vehicles if that is SFMTA's agenda.

Hello Christin, Lisa, and Bruce,

I received your emails and appreciate the outreach ideas. I've also completed compiling bikeshare data in the surrounding area. Finally, I'll address proposed station details and system inquiries which have been trickling in through our email exchanges.

Outreach

Let me check with Bay Wheels and the Bikeshare Program Team about what makes the most sense for outreach events. The agency usually conducts larger format community meetings around major changes like corridor re-designs or major transit routing overhauls. Bikeshare stations, on the other hand, are closer to the impact level of bus stops and loading zones. They shuffle usage of the curb space, but they don't actually change the throughway of the road with only minimal impact to the built environment. Our program generally prefers to visit community meetings and present specific details to interested and involved participants, in addition to the standard postings, mailings, and notifications.

You mentioned the HAMA October agenda being full. We might be fine pushing until November. While it is later than anticipated, let me check with other program staff. I don't want to rush you, and if you need more time to process the proposal and notify folks, I want to try and provide that.

Data

Both Lisa and Bruce asked for ridership data for surrounding stations. I'm including the following two tables of data (which can be found on the dashboard Neal previously linked).

Some introduction is necessary. Take note of how the stations around the proposed Haight/Belvedere location have fluctuated over time, both due to changes in the service and changes in demand and travel-patterns—specifically ebikes and the Coronavirus Pandemic. Some of the stations have been around pre-pandemic (Fell/Stanyan, Carl/Cole), and others weren't operational at the requested query date Jan 1, 2022 (Waller/Stanyan, Page/Masonic).

This first table shows station usage since any neighboring stations existed. Fell/Stanyan and Carl/Cole have 2.5y and 3.5y more time than the other two, respectively. I've included a monthly-ridership column to pull out how all four surrounding stations show strong usage throughout their existence, though some are definitely more popular than others.

This second table shows station usage since 1/1/22. As expected, the ridership for 2022 is lower, but I believe we would agree these numbers still show strong usage. Honestly, it's not surprising because the Upper Haight, and its surrounding areas have a lot of trips, both from being arguably the western edge of multi-family density in SF, along with the large number desirable destinations to shop, eat and recreate.

These are only a snapshot. Zooming out, bikeshare has grown during recovery. In the midst of pandemic, people chose bikeshare as the primary alternative to driving, without having to be in an enclosed transit vehicle. Our ridership steadily increased since the middle of 2021, and we currently

have higher ridership than 2019, largely due to more adoption and a larger system. Bikeshare expansion allows it to become a viable option for more trips and more riders, ultimately reducing the overall dependency on cars, helping to reduce congestion and parking competition.

Also to keep in mind, station data is only part of the answer. With stationless bikes, the ridership to the Upper Haight is larger than just station activity. Below is a snapshot of a map of August trips with either stationless beginnings and/or endings in the area. While the bikeshare system benefits from stationless service, we still see stations as the cornerstone of the program because stations help keep bikes more organized, and reduce operational cost by with predictability for staff. In August, almost 25% of trips either began and/or ended without a station. I'm comfortable approximating that as +>12% total trips in the area unaccounted for in the station tables above.

Proposed Station Details

The proposed station would be ~58 feet long, which is roughly the equivalent length of three metered spaces. For remaining stations and overall system expansion, I'm pleased to say this is the last station to be proposed for this area, since it would plug this gap in the network. I've previously written Sup Preston and D5 aides this would be "The Ultimate Station" here, with no other new proposed installations in the next 2-3 years, or during the remainder of the contract until 2027.

Finally, for Page/Masonic, the move across the intersection was simply to accommodate a sewer construction project, and it will be moved as soon as the project is completed and repaved.

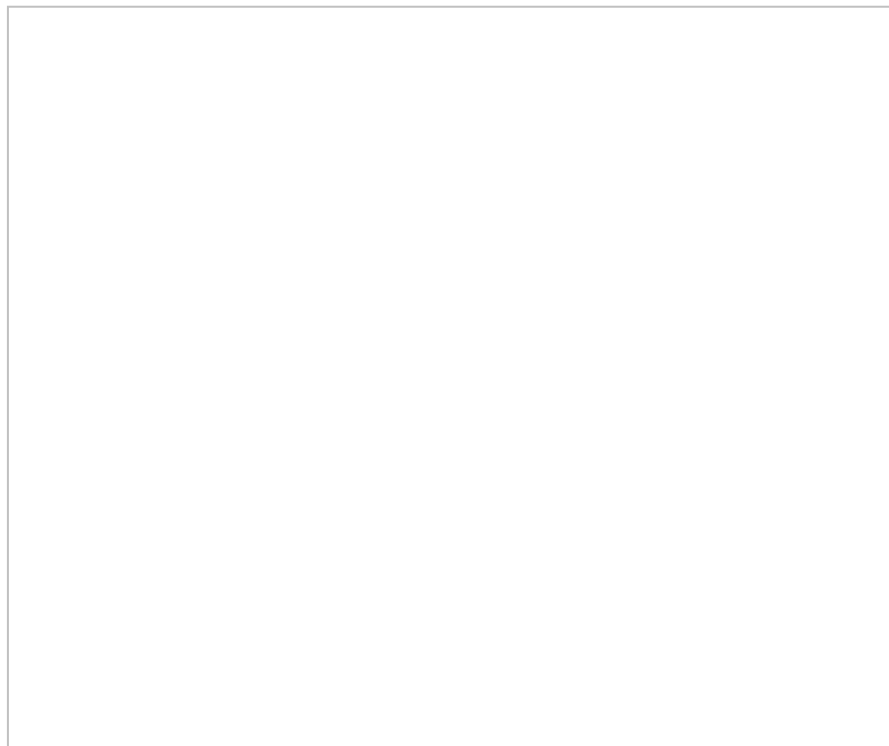

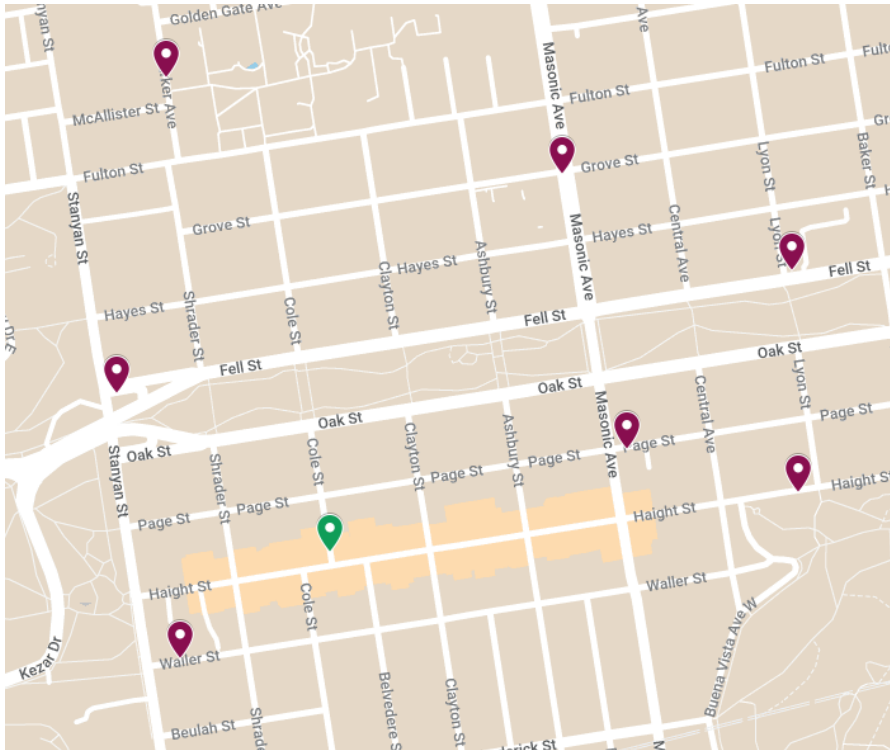

PROJECT DESCRIPTION:

The San Francisco Municipal Transportation Agency (SFMTA) proposes to implement a city-wide bicycle sharing system in San Francisco as part of the regional Bay Area Bicycle Share (BABS) system described in detail below. The current regional bicycle share system in San Francisco is a pilot project managed by the Bay Area Air Quality Management District (BAAQMD). The regional BABS system will transfer to the Metropolitan Transportation Commission (MTC) for program oversight at the end of 2015. As part of a BABS pilot project initiated on August 29, 2013, the system operator installed approximately 35 bicycle share stations with input from the SFMTA, comprising 350 bicycles within the public right-of-way, located generally in the northeast section of the City. The proposed project would maintain and upgrade the existing 35 pilot bicycle share stations, and expand the BABS system within San Francisco to comprise a total of approximately 450 stations and 4,500 bicycles across the City and County of San Francisco (San Francisco).

DETERMINATION:


The City and County of San Francisco decided to carry out or approve the project on December 18, 2015. The San Francisco Board of Supervisors (BOS) approved a coordination agreement with the Metropolitan Transportation Commission (MTC), other local partners in the East and South Bay, and the bicycle share operator to carry out the Bay Area Bicycle Share Program, which would be overseen in San Francisco by the San Francisco Municipal Transportation Agency (SFMTA) on December 8, 2015. The agreement was provided to Mayor Lee for his signature and becomes effective upon signing or when ten days have passed. - Community Plan Exemption (Sec. 21083.3; 15183)

- 2. This project in its approved form has been determined to be exempt from environmental review because it would result in the installation of up to 450 bicycle sharing stations throughout San Francisco, primarily within the public right-of-way and on some parcels. The proposed individual stations are portable, modular, and would be solar and battery powered, and would thus not involve excavation or utility connections. The bicycle sharing station equipment is small in scale and massing relative to surrounding buildings or sites. Bicycle facilities and infrastructure are common sights within the urban environment. There would be no potential for significant environmental impacts at either a project or cumulative level. Therefore, the proposed project would be exempt from environmental review under Class 3.
