### **ESTABLISH – YELLOW ZONE, COMMERCIAL LOADING, 30-MIN LIMIT, AT ALL TIMES**

“5” Jones Street, west side, from 42 feet to 142 feet north of McAllister Street, replacing metered stalls #5, #7, #9, #11, #15 (100-foot zone)

### **ESTABLISH – RED ZONE, NO PARKING ANY TIME**

“3” Jones Street, west side, from 22 feet to 42 feet north of McAllister Street replacing metered stall #3 (20-foot zone)
