### **ESTABLISH – WHITE ZONE, PASSENGER LOADING 7AM TO 10PM, DAILY**

33 Seneca Avenue, south side, from 2 feet to 44 feet east of the building driveway (42-foot zone, two parking spaces)

-No opposition received, forwarded for implementation by directive 6078.

### **ESTABLISH – METERED YELLOW ZONE, COMMERCIAL LOADING, ~~30-MINUTE~~ 1-HOUR TIME LIMIT, 9AM TO 6PM, MONDAY THROUGH SATURDAY**

250 14<sup>th</sup> Street, north side, from 149 feet to 167 and from 186 feet to 206 west of South Van Ness Avenue at metered stall no. 212 and 216 (18-foot zone and 20-foot zone, two parking spaces)

### **ESTABLISH – WHITE ZONE, PASSENGER LOADING, 6PM TO ~~MIDNIGHT~~ 2AM, DAILY**
