Legend

Phase: phase of the Slow Street Program in which the corridor was originally implemented.

Origin: refers what entity identified the corridor as a Slow Streets candidate: SFMTA (initial engineering/topographical analysis), Replacement (SFMTA/CBO alternative to unsuitable corridor), CBO (community group), survey (responses to SFMTA administered Slow Streets survey).

Transportation: This corridor fills a gap in the existing active transportation network and/or provides additional transportation benefits.

Equity: The corridor's equity score as defined by the program's Draft Equity Action Plan evaluation tool.

Maintenance: Corridors with outstanding or ongoing materials or maintenance needs
