### 5. Report of the Chair (For discussion only)

Chair Chen reported on upcoming agency changes. He presented a slide presentation on Council member priorities.

No public comment.

### 6. Public Comment:

Richard Rothman stated that there is no outside oversight on the budget. If the agency wants to be trusted by the people, there needs to be oversight. The SFMTA Board needs to listen to the public.

Edward Mason stated that he attempted to call the 888 number for the MTA Board special meeting on Tuesday, August 17<sup>th</sup> and for over half an hour off and on, there was no communication via the telephone. He inquired if the meeting was conducted.

Mike Regan stated that there are 13,000 people who signed a petition to keep the Great Highway open. Only 2.2% of people ride bikes in the Sunset. Citywide bike ridership is only 7%. This is a regional issue. The Great Highway is the safest way for motor vehicles to move through the Sunset. Please stop penalizing motorists to appease the bike coalitions 7% cyclists.

Lorraine Petty stated that the agency needs to produce the plan to restore lines including the full J Church service, the 31, and the 21 lines. Restoring service is critical to getting riders to use the service again.

David Pilpel stated that there should be documents available on the 2022 Service Plan prior to the next meeting. The Board of Supervisors asked for a written service restoration plan from the SFMTA.

Diana Hammons, Senior Manager, Revenue Collection & Sales presented the item. Eliska Ferdinand and Alan San Martin, Staff, Proof of Payment assisted in presenting the item.

#### PUBLIC COMMENT:

Calvin Quick stated that he is extremely happy to see this program roll out. He expressed appreciation to SFMTA and community advocates.

Hayden Miller stated concern about identifying someone's age by looking at them. There should be more outreach to let the youth know about the program.

David Pilpel suggested the slogan Free Muni for YOU.

8. Presentation, discussion, and possible action regarding Muni 2022 Service Plan. (Sean Kennedy, Manager, Transit Planning. No explanatory documents.)

Sean Kennedy, Manager, Transit Planning, presented the item.

Hayden Miller suggested having an outreach event specifically for youth.

David Pilpel stated that it would be good to start with assumptions and principles that drive the map, span, and coverage. He would like to see as much or more service with fewer lines. He suggested combining lines like the 66 and the 35.
