David Pilpel had no changes to the minutes but expressed sadness to hear of Ruach Graffis's passing.

Chair Borden discussed the virtual meeting and expressed appreciation to staff for their work to enable the meeting to be held via teleconference. Board Secretary Silva reviewed how members of the public could watch the meeting and address the Board.

Director Tumlin shared a transit update, updates to the Van Ness Improvement Project and Central Subway Project, disclosed a side letter agreement with the International Brotherhood of Electrical Workers, Local 6 union, and shared news about the Bayview Community Based Transportation Plan winning the Advancing Diversity & Social Change in Honor of Paul Davidoff National Award of Excellence from the American Planning Association.

Director Heminger requested to test out cable cars in advance of the fall cable car service restart.

PUBLIC COMMENT:

Luke Bornheimer expressed concern over the federal mask requirement, thanked staff for late night service and reminded attendees of the incident at Polk and Hayes Streets.

Aleta Dupree expressed appreciation for removing capacity restrictions and looked forward to electric busses and restarting cable car service.

Harry requested that the SFMTA restore the 43 Masonic, 18 46<sup>th</sup> Avenue & 23 Monterey lines.

David Pilpel requested that the slide presentation and any reference materials be posted to the website, questioned which staff should present on Capital Project and Construction Division projects, and questioned the sufficiency of the side letter posting.

Barry Taranto requested that the Tutor Perini letter be posted to the website and expressed concern with the Van Ness Improvement Project.

Susy Randecker expressed concern regarding free cable car service for tourists and frequency of transit service.

Eric Rosell expressed concern regarding the August restoration of transit service and urged the SFMTA to restore the 31 Balboa line.

Chris Arvin thanked the SFMTA for recent late night service changes and Director Yekutieli for his outreach on the matter.

Hayden Miller thanked the SFMTA for late night service and restoring the 28 19<sup>th</sup> Avenue line and expressed opposition to allowing free cable car service to tourists.

Hamilton Carter thanked the SFMTA for evening busses and requested restoring the 44 O'Shaughnessy line as well as the 43 Masonic line.

Simon Deloria urged the SFMTA to restore the 31 Balboa line.

Dave Alexander expressed concern regarding the intersection of Polk and Hayes Streets and urged the SFMTA to restore the 31 Balboa line in order to activate Balboa Village.

## 8. Citizens' Advisory Council Report

Neil Ballard, Chair, Citizens' Advisory Council (CAC), presented the report.

Chair Borden thanked Neil Ballard for his time and leadership as chair of the CAC.

### PUBLIC COMMENT:

David Pilpel commended CAC Secretary Keka Robinson-Luqman and was sorry to hear that Neil Ballard would no longer be on the CAC.

## 9. Public Comment

Richard Rothman shared collision data from a Police Department report and expressed concern regarding the Great Highway.

Aleta Dupree looked forward to riding Muni soon and advocated for an open payment system.

Chris Arvin expressed support for restoration of the 31 Balboa line by the end of the year and urged the SFMTA to embrace riders wanting their service back.

Barry Taranto urged the SFMTA to allow more taxi drivers access to the airport and expressed concern over no right turn red lights in the Tenderloin.

David Pilpel observed Director Brinkman's absence and urged the Board to post its correspondence or create a log.

Stacy Randecker thanked Director Yekutieli for his previous comments regarding Great Highway at the special joint meeting.

Hayden Miller expressed interest in recent organization changes and thanked Neil Ballard and Keka Robinson-Luqman for their work on the CAC.

Luke Bornheimer thanked staff and the Board for the special joint meeting the previous week and urged them to support the Great Highway pilot project.

Joe Kelly expressed concern regarding inefficient frequency of the N Judah line, urged the SFMTA to reopen the Great Highway, and expressed concern regarding unused bicycle lanes.

Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those

issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
