The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, August 15, 2014, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

- 1(a). **ESTABLISH – STOP SIGNS**
47th Avenue, northbound and southbound, at Wawona Street, making this intersection and all-way STOP
- 1(b). **ESTABLISH – FLAG STOP**
47th Avenue, west side, north of Wawona Street
- 1(c). **RESCIND – FLAG STOP**
47th Avenue, west side, south of Wawona Street (outbound #18 46th Avenue Muni stop, relocating from far side to near side on southbound 47th Avenue)
- 2(a). **ESTABLISH – CROSSWALK**
Hayes Street at Pierce Street (east side crossing)
- 2(b). **ESTABLISH – BUS ZONE**
Hayes Street, north side, from Pierce Street to 60 feet easterly (shifting existing 60-foot bus zone 29 feet)
3. **ESTABLISH – STOP SIGNS**
Ulloa Street, eastbound and westbound, at 26th Avenue, making this intersection an all-way STOP
4. **ESTABLISH – RESIDENTIAL PERMIT PARKING AREA Y, 2-HOUR PARKING 9 AM TO 9 PM, MONDAY THROUGH FRIDAY**
 - A. Berry Street, north side, from 7th Street to 248 feet westerly (500 Block)
 - B. Berry Street, south side, from 7th Street to 300 feet westerly (500 Block)
 - C. King Street, south side, between 7th and Division streets (600 Block)
- 5(a). **ESTABLISH – TOW-AWAY NO STOPPING ANYTIME**
Geneva Avenue, south side, from 55 feet to 185 feet east of San Jose Avenue (extends existing 55-foot zone)
- 5(b). **ESTABLISH – RIGHT LANE MUST TURN RIGHT EXCEPT MUNI**
Geneva Avenue, westbound, at San Jose Avenue
6. **ESTABLISH – STOP SIGN**
Rossi Avenue, southbound, at Turk Street, stopping the stem of this "T" intersection

Hopkins Avenue, westbound, at Burnett Avenue, stopping the stem of this "T" intersection

 - B. Orizaba Avenue, west side, from Randolph Street to 70 feet southerly (6 foot wide bulb-out, 70 foot long bulb)
 - C. Orizaba Avenue, east side, from Randolph Street to 100 feet northerly (25 foot wide bulb-out, 100 foot long bulb)
 - D. Randolph Street, north side, from Bright Street to 25 feet westerly (6 foot wide bulb-out, 25 foot long bulb)
 - E. Randolph Street, south side, from Bright Street to 25 feet westerly (6 foot wide bulb-out, 25 foot long bulb)
 - F. Randolph Street, south side, from Head Street to 30 feet westerly (6 foot wide bulb-out, 30 foot long bulb)

Alhambra Street, between Mallorca Way and Pierce Street *

Categorically exempt from Environmental Review:
Class 1(c) (5) all work on sidewalks, curbs and gutters without changes in curb lines, including lowering of curbs for driveways, and additions of sidewalk bulbs when not in conjunction with a program for extensive replacement or installation; and Class 1(c) (9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street.

Administrative Code Section 31.16, typically within 30 calendar days of the Approval Action. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.
