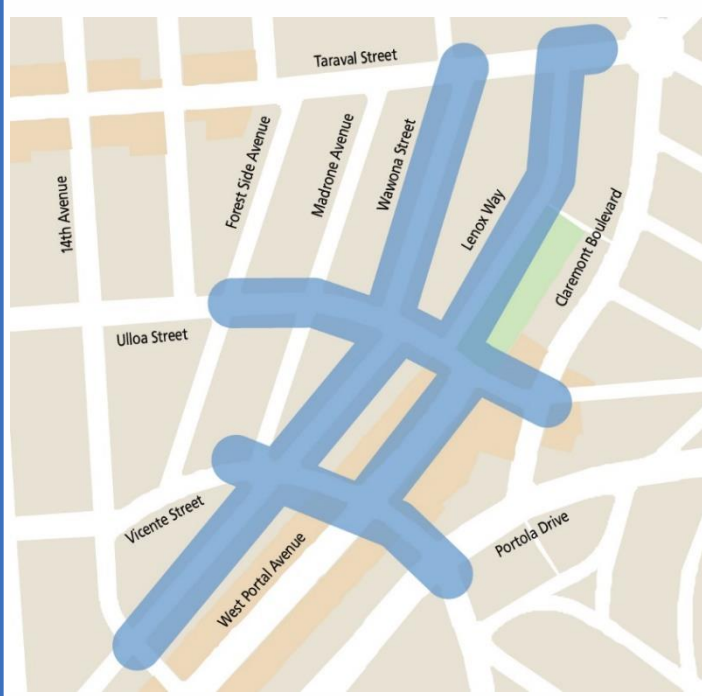

## West Portal Station Safety and Community Improvements

The West Portal Station Safety and Community Improvements Project aims to improve safety near West Portal Station. It includes proposed improvements to calm traffic on Ulloa and Vicente streets and to simplify the West Portal Avenue and Ulloa Street intersection where ~5,000 Muni riders board each day.

West Portal 站安全與社區空間改善計畫 (West Portal Station Safety and Community Improvements Project) 旨在改善 West Portal 站附近的安全。其中包括擬議的改進措施，以減緩 Ulloa 和 Vicente 街的交通，並簡化 West Portal 和 Ulloa 交叉路口，在這裡，每天約有 5,000 名 Muni 乘客乘車。

El Proyecto de Mejoras Comunitarias y de Seguridad de la Estación de West Portal tiene como objetivo mejorar la seguridad en los alrededores de la Estación de West Portal. Se incluyen las mejoras propuestas para atenuar el tráfico en las calles Ulloa y Vicente, y para simplificar la intersección de West Portal y Ulloa, donde cada día suben unos 5.000 pasajeros al Muni.

### A public hearing on the project proposals will be held on Tuesday, July 16, to take public comment, discuss and vote on adoption of the West Portal Station Safety and Community Improvements' traffic and parking changes, including:

- Adding safety improvements to enhance visibility, slow down traffic and improve intersection safety at nearby blocks on Ulloa Street, Vicente Street, Wawona Street and Lenox Way.
- Restricting left turns for northbound private vehicles from West Portal Avenue onto westbound Ulloa Street.
- Restricting left turns for southbound private vehicles from West Portal Avenue onto eastbound Vicente Street.
- Restricting westbound through traffic for westbound private vehicles on Ulloa Street at West Portal Avenue.
- Installing a transit lane in the center northbound lane on West Portal Avenue from Ulloa Street to 230 feet southbound and in the center southbound lane on West Portal Avenue from Ulloa Street to 120 feet southbound.

- Converting Lenox Way traffic to one-way southbound between Taraval and Ulloa streets to improve safety on Ulloa Street.
  - Other changes including the removal of the 57 Parkmerced bus stop on Vicente at West Portal, re-routing the 91 Owl and terminal stop and changes to curb designations on portions of Lenox Way and Ulloa, Vicente and Taraval streets.

The SFMTA Board will be asked to decide whether to approve the proposed changes.
