Sustainable Streets Division Directive Order No. 6796

Pursuant to the public hearing held on August 2, 2024, traffic movement and safety may be improved by the changes approved below. The Environmental Clearance for these items is noted on Order No. 6789.

1. ESTABLISH – RESIDENTIAL PERMIT PARKING AREA W (Eligibility only, no signs)

2800 block of 24th Street between Bryant and York Streets excluding parcels already in W (Supervisor District 9) (Requires approval by the SFMTA Board) Gerry Porras, gerry.porras@sfmta.com

The proposed modification would add RPP eligibility to the residents of the 2800 block of 24th Street between Bryant and York Streets excluding parcels already in W so they can purchase parking permits for their vehicle to park within RPP Area W.

Public Comments: Question raised about what “eligibility only” meant.

Decision: Approved by the City Traffic Engineer to forward to the SFMTA Board for final approval and implementation.

2. ESTABLISH – RESIDENTIAL PERMIT PARKING AREA Z (Eligibility only, no signs)

3550 Cesar Chavez Street; 1500 Valencia Street (Supervisor District 8) (Requires approval by the SFMTA Board) Gerry Porras, gerry.porras@sfmta.com

The proposed modification would add RPP eligibility to the residents of the 3550 Cesar Chavez Street; 1500 Valencia Street so they can purchase parking permits for their vehicle to park within RPP Area Z. Note: The areas between 26th Street and Cesar Chavez Street will be getting meters in the future.

Public Comments: Question raised about what “eligibility only” meant.

Decision: Approved by the City Traffic Engineer to forward to the SFMTA Board for final approval and implementation.

3. ESTABLISH – STOP SIGN

Peru Avenue, westbound, at Valmar Terrace (Supervisor District 11) (Approvable by the City Traffic Engineer) Juan Hernandez, juan.hernandez@sfmta.com

Proposal to stop the stem of this T-intersection to clarify the right-of-way.

Public Comments: No comments.

Decision: Approved by the City Traffic Engineer for implementation. #

Russia Avenue, westbound, at Mission Street (Supervisor District 11) (Approvable by the City Traffic Engineer) Ellen Robinson, ellen.robinson@sfmta.com

Proposal to implement a right-turn only restriction from Russia Avenue onto Mission Street to address collision history.

Public Comments: No comments.

Decision: Approved by the City Traffic Engineer for implementation.

5. ESTABLISH – STOP SIGNS

Clement Street, eastbound and westbound, at 26th Avenue

Clement Street, eastbound and westbound, at 28th Avenue

(Supervisor District 1) (Approvable by the City Traffic Engineer) Jasper Lee, jasper.lee@sfmta.com
Proposal to convert these intersections to all-way STOP.

Public Comments: Received comments in support. Questions raised regarding the status of STOP sign installation at Clement Street at 28th Avenue, and reconsideration for STOP signs at Balboa Street at 38th Avenue.

Decision: Clement Street at 28th Avenue withdrawn (already legislated at a previous public hearing). Clement Street at 26th Avenue approved by the City Traffic Engineer for implementation. #

6(a). RESCIND – NO LEFT TURN, 7 AM TO 7 PM, EXCEPT SATURDAY AND SUNDAY

Divisadero Street, southbound, at Geary Boulevard

6(b). ESTABLISH – NO LEFT TURN, AT ALL TIMES

Divisadero Street, southbound, at Geary Boulevard

(Supervisor Districts 2 and 5) (Approvable by the City Traffic Engineer) Jasper Lee, jasper.lee@sfmta.com

Proposal to convert southbound no left turn restriction from part-time to full-time to address intersection collisions.

Public Comments: Received comments in opposition. Concerns raised regarding the potential added congestion to the area and questioned the need for such a restriction. Comment raised regarding suggested alternate routes.

Decision: Approved by the City Traffic Engineer for implementation.

7(a). ESTABLISH – GENERAL METERED PARKING, NO TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY

Plum Street, north side, from 20 feet to 289 feet east of Mission Street

7(b). ESTABLISH – YELLOW METERED ZONE, 60-MINUTE TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY

7(c). ESTABLISH – RED ZONE

Plum Street, north side, from Mission Street to 20 feet easterly

7(d). RESCIND – 6-WHEEL TRUCK LOADING ZONE, 7 AM TO 6 PM, MONDAY THROUGH FRIDAY

Plum Street, north side, from 67 feet to 108 feet east of Mission Street

(Supervisor District 6) (Requires approval by the SFMTA Board) Lulu Brien, lulu.brien@sfmta.com

Proposal to convert an unregulated block to regulated metered parking.

Public Comments: Received email prior to public hearing requesting clarification of the proposed changes, with concerns for access to existing driveways and loading docks. Received comments in opposition during public hearing citing the loss of free unregulated parking. Concerns raised regarding the financial impact, as well as the lack of disabled parking nearby for elderly clients.

Decision: Added clarification of the rescission of an existing 6-Wheel Truck Loading Zone as part of the proposed meter establishment. Approved by the City Traffic Engineer to forward to the SFMTA Board for final approval and implementation.

8(a). ESTABLISH – STOP SIGN

Perego Terrace, northbound, at Burnett Avenue

8(b). ESTABLISH – RED ZONE

Burnett Avenue, south side, from Perego Terrace to 35 feet westerly (extends existing 8-foot hydrant red zone to 35 feet)

(Supervisor District 8) (Approvable by the City Traffic Engineer Edward Tang, edward.tang@sfmta.com)

Proposal to stop the stem of the T-intersection to clarify the right-of-way and to establish red zone to increase visibility.

Public Comments: No comments.

Public Comments: Received emails prior to public hearing in support of Alemany Boulevard and Fulton Street. Received comments in support during public hearing with suggestions to reduce further on Sloat Boulevard. Requests made for additional enforcement, turn restrictions for eastbound left on Fulton at Funston and for northbound right on Park Presidio at Fulton, and additional traffic calming measures.

Decision: Approved by the City Traffic Engineer to forward to the SFMTA Board for final approval and implementation.

Decision: Corrected item numbering sequence. Approved by the City Traffic Engineer to forward to the SFMTA Board for final approval and implementation.

GENERAL COMMENTS:

- Request to schedule a Walk Audit with SFMTA staff for Arguello Boulevard, Fulton Street and other streets in the Richmond District
- Request to increase the pedestrian crossing time at 37th Avenue and Fulton Street
- Late agenda posting; paper notices on utility poles are not sufficient; color curb changes should not be on the Engineering public hearing
- Multiple items for a large project, such as items 10 through 12, should not be combined and heard as one item

Whether or not the City Traffic Engineer's decision is considered a Final SFMTA Decision is determined by Division II, Section 203 of the Transportation Code. If the City Traffic Engineer approves a parking or traffic modification, it is considered a Final SFMTA Decision. If the City Traffic Engineer disapproves or declines a parking or traffic modification, a member of the public must request additional review by the SFMTA of that decision which shall be conducted pursuant to Division II, Section 203 of the Transportation Code before the decision becomes a Final SFMTA Decision. Final SFMTA Decisions, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors pursuant to [Ordinance 127-18](#). Decisions reviewable by the Board of Supervisors are denoted with a pound (#).
